A RESOLUTION EARNESTLY SUPPORTING THE PLAN OF PHILIPPINE RICE RESEARCH INSTITUTE TO CONDUCT FIELD TRIAL OF GOLDEN RICE, IN THE BARANGAY CARAYCAYON, TIGAON. CAMARINES SUR.

WHEREAS, Vitamin A Deficiency (VAD) is prevalent among young children and **lactating** women and the main cause not only of blindness but also of malnutrition and mortality in the Philippines;

WHEREAS, Vitamin A is essential nutrient needed for the visual system, **growth**, development, and a healthy immune system. Everybody needs Vitamin A to grow and **thrive**, particularly mother and young children;

WHEREAS, Golden rice is a new type of rice developed through modern biotechnology that contains beta-caroptene (a vitamin A precursor) in the grain. Studies have shown that consuming about a cup of Golden Rice can supply half the total daily need for vitamin A of an adult;

WHEREAS, the Philippine Rice Research Institute is the lead agency in the development of Golden Rice and has just satisfactorily completed laboratory testing and shall now commence field trials;

WHEREAS, the recommended site is the farm lot at Sitio Ambawan, Caraycayon, this municipality, and the recommended farmer therefore is Mr. Elmer L. Orfanel;

WHEREAS, this local legislative council always supportive to any undertakings that will uplift the economic and nutritional status of local farmers and consumers;
