RESOLUTION EXPRESSING FORMAL SUPPORT FOR THE CONDUCT OF THE FIELD TRIALS AND SCIENTIFIC STUDIES ON GOLDEN RICE IN THE MUNICIPALITIES OF PILI AND TIGAON, CAMARINES SUR

WHEREAS, one of the health problems among the Filipino families is the deficiency in Vitamin A, they don't get enough Vitamin A or beta carotene from the food they eat. Research show that four (4) out of ten (10) Filipino children ages 6 months to 5 years old are estimated to be Vitamin A deficient, while close to 18% of pregnant women suffer from subclinical VAD. It is an established medical fact that VAD leads not only to blindness but more on malnutrition and worst, mortality;

WHEREAS, one important tool being developed to help address this social malady is through the development and consumption of Golden Rice, it is a new type of rice developed through modern biotechnology that contains beta carotene (Vitamin A) in the grains. Studies have shown that consuming about a cup of golden rice can supply half the total daily need for Vitamin A of an adult;

WHEREAS, rice is widely produced and consumed, golden rice has the potential to reach many people including those who do not have the access and cannot afford other sources of Vitamin A. Golden Rice is intended to be used in combination with existing intervention approaches to overcome Vitamin A deficiency including eating food that are naturally high in Vitamin A;

WHEREAS, to help establish the safety of golden rice in the environment, field tests and other evaluation will be conducted, thus, the Philippine Rice Research Institute (PhilRice) have chosen the municipalities of Pili and Tigaon, Camarines Sur as the two (2) trial sites for the development, scientific studies and production of golden rice;

WHEREAS, in consideration of the importance of the field trial on golden rice to be conducted in the two municipalities of Camarines Sur, the Provincial Government appreciates the opportunity of having chosen as the site for its development and strongly expressing formal support for the conduct of the field trials and other scientific studies in the production of golden rice in Pili and Tigaon, Camarines Sur;
