PROVINCIAL RESOLUTION NO. 112-2012

RESOLUTION EXPRESSING THE FORMAL SUPPORT FOR THE CONDUCT OF THE FIELD TRIAL AND SCIENTIFIC STUDIES ON GOLDEN RICE IN THE CITY OF BATAC, ILOCOS NORTE.

WHEREAS, one of the health problems among the Filipino families is the deficiency in Vitamin A, they don't get enough Vitamin A or beta carotene from the food they eat. Research shows that four (4) out of ten (10) Filipino children ages six (6) months to five (5) years old are estimated to be Vitamin A Deficient, while close to eighteen percent (18%) of pregnant women suffer from subclinical Vitamin A Deficient (VAD). It is an established medical fact that VAD leads not only to blindness but more on malnutrition and worst, mortality;

WHEREAS, one important tool being developed to help address this social malady is through the development and consumption of Golden Rice. Golden Rice is a new type of rice developed through modern biotechnology that contains beta carotene (Vitamin A) in the grains. Studies have shown that consuming about a cup of golden rice can supply half the total daily need for Vitamin A of an adult;

WHEREAS, rice is widely produced and consumed and golden rice has the potential to reach many people including those who do not have the access and cannot afford other sources of Vitamin A. Golden Rice is intended to be used in combination with existing intervention approaches to overcome Vitamin A Deficiency including eating food that are naturally high in Vitamin A;

WHEREAS, to help establish the safety of Golden Rice in the environment, field tests and other evaluation trials will be conducted, thus, the Philippine Rice Research Institute (PhilRice) had chosen Batac City as one of the testing sites;

NOW, THEREFORE, Be it Resolved, as it is hereby Resolved, to express formal support for the conduct of the Field Trial and Scientific Studies on Golden Rice in the City of Batac, Ilocos Norte.
