



INVITATION TO BID FOR THE PROCUREMENT OF SERVICE PROVIDER FOR DIGITAL MARKETING TO PROMOTE THE PHILRICE RCEF SEED PROGRAM UNDER THE NEW NORMAL THROUGH SOCIAL MEDIA UNDER RCEF GOODS 20-07-06A

- 1. The Philippine Rice Research Institute, through the 2020 Rice Competitiveness Enhancement Fund intends to apply the sum of TWO MILLION AND 00/100 ONLY (Php 2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Service Provider for Digital Marketing to Promote the PhilRice RCEF Seed Program under the New Normal Through Social Media under RCEF Goods 20-07-06A. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Rice Research Institute now invites bids for the **Procurement of Service Provider for Digital Marketing to Promote the PhilRice RCEF Seed Program under the New Normal Through Social Media under RCEF Goods 20-07-06A.**
 - Delivery of the Goods is required within the period specified in the Schedule of Requirements. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from PhilRice through telecommunication or video conferencing during office hours, kindly refer to the schedule below.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by GPPB, in the amount of **Two Thousand Pesos (Php 2,000.00)**





It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

We encourage bidders to download the bidding documents through PhilGEPS or the PhilRice website and pay through bank. Please coordinate with the BAC Secretariat through the email address and contact number given below for the bank details and procedures.

- 6. The Philippine Rice Research Institute will hold an online/virtual Pre-Bid Conference on the date specified below which shall be open to all prospective bidders. A Personal Meeting ID will be sent through SMS or email for each participant at least one day before the event. Prospective bidders need to signify their intention to participate by sending an email to the address given below.
- 7. Bids must be duly received by the BAC Secretariat at the address below one (1) day before the opening of bids. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Face to Face and Virtual/Online Bid opening shall be held on **October 06, 2020; 09:30AM** at PhilRice Maligaya, Science City of Muñoz, N.E. Bids will be opened in the presence of the bidders' representatives (*limited number only*) who choose to attend at the address below. Late bids shall not be accepted.

- 8. The Philippine Rice Research Institute reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
