WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Various Agricultural Supplies under PB 20-03-23** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **August 12 to September 1, 2020**;

WHEREAS, in response to the said advertisements, there are three (3) prospective bidders listed in PhilGEPS documents request list (DRL) that accessed the bidding document but only one (1) bidder EJA Agritech Corporation who purchased the bidding documents and submitted proposal;

WHEREAS, during the opening of bids held last September 3, 2020, **EJA Agritech Corporation**, was rated **PASSED** in the eligibility and technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the **approved budget for this contract (ABC) is One Million Seven Hundred Four Eight Hundred Seventy Three Pesos and 60/100 only (PhP1,704,873.60)**;

WHEREAS, the financial proposal of EJA Agritech Corporation was found to be substantially complying and read as follows:


