

**BAC Resolution Declaring Failure of Bidding for
Supply and Delivery of 100 Rolls S2 Tarpaulin Sheets (PB 21-01-02)**

**BAC RESOLUTION No. 34
Series of 2020**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of 100 Rolls S2 Tarpaulin Sheets (PB 21-01-02)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **October 16 to November 09, 2020**;

WHEREAS, in response to the said advertisements, three (3) prospective bidders were listed in the PhilGEPS document request list, but only two (2) bidders purchased the bidding documents and submitted proposals on time, 1) **Anglowealth Enterprises**, and 2) **UP-Town Industrial Corporation**.

WHEREAS, the total approved budget for the contract (ABC) is **One Million One Hundred Eighty Thousand Pesos Only (PhP1,180,000.00)**;

WHEREAS, during the submission and opening of bids held last **November 09** and **November 10, 2020**, respectively, both bidders was rated **PASSED** in the eligibility and technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of Anglowealth Enterprises and UP-Town Industrial Corporation were found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding and sample of the tarpaulin sheet, the bid of both bidders, Anglowealth Enterprises and UP-Town Industrial Corporation were **not successful in meeting the technical specifications required**.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **DECLARE failure of bidding** for the **Supply and Delivery of 100 rolls S2 Tarpaulin Sheets (PB 21-01-02)** and recommend to review and evaluate the technical specifications and/or budget then for re-bid;
- b) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
