







BAC Resolution Declaring Failure of Bidding for Supply and Delivery of one (1) unit Brand new Farm Tractor (PB 20-04-32)

BAC RESOLUTION No. 41 Series of 2020

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the Supply and Delivery of one (1) unit Brand new Farm Tractor (PB 20-04-32) in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from October 16, 2020 to November 09, 2020;

WHEREAS, in response to the said advertisements two (02) prospective bidders were listed in the PhilGEPS document request list, but only one bidder, Agri Component Corporation purchased the bidding documents and submitted proposals on time;

WHEREAS, the total approved budget for the contract (ABC) is Four Million and 00/100 Pesos Only (PhP4,000,000.00);

WHEREAS, during the submission and opening of bids held last November 09 and 10, 2020, respectively, Agri Component Corporation was rated PASSED in the eligibility and technical requirements and declared to be ELIGIBLE;

WHEREAS, the financial proposal of the bidder was found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted, the BAC and the TWG found out that bid **failed** to comply with, and be responsive to, the requirements and conditions specified in the Bidding Documents particularly referring to the coupled test results for the tractor and rotavator and the detailed specifications of the laser guided leveling attachment.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby RESOLVED:

- a) That **Agri Component Corporation** was hereby declared post-disqualified;
- b) To **DECLARE failure of bidding** for the Supply and Delivery of one (1) unit Brand new Farm Tractor (PB 20-04-32) and recommend to review and evaluate the technical specifications and/or budget then for re-bid;
- c) To **RECOMMEND** for approval by the foregoing findings.
