

**BAC Resolution Declaring Failure of Bidding for
Supply, Delivery and Installation of one (1) unit Lathe Machine and one (1) unit
Plasma Cutter (PB 20-04-33A)**

**BAC RESOLUTION No. 04
Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply, Delivery and Installation of one (1) unit Lathe Machine and one (1) unit Plasma Cutter (PB 20-04-33A)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **December 08 to 23, 2020**;

WHEREAS, in response to the said advertisements five (5) prospective bidders were listed in the PhilGEPS document request list, but only one bidder, Solid Steel Machinery and Tools, Inc. purchased the bidding documents and submitted proposals on time;

WHEREAS, the total approved budget for the contract (ABC) is **One Million Four Hundred Eight Thousand and 00/100 Pesos Only (PhP1,408,000.00)**;

WHEREAS, during the submission and opening of bids held last **December 28, 2020**, Solid Steel Machinery and Tools Inc. was rated **PASSED** in the eligibility and technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of the bidder was found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted, the BAC and the TWG found out that bid **failed** to comply with, and be responsive to, the requirements and conditions specified in the Bidding Documents particularly referring to the documents on certificate of distributorship by the principal, proof of existence of the product in the local market and the detailed specifications of the plasma cutter.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) That **Solid Steel Machinery and Tools, Inc.** was hereby declared post-disqualified;
- b) To **DECLARE 2nd failure of bidding** for the **Supply, Delivery and Installation of one (1) unit Lathe Machine and one (1) unit Plasma Cutter (PB 20-04-33A)** and to recommend to review and evaluate the technical specifications and/or budget;



- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
