BAC RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BIDDER and AWARD FOR THE SUPPLY and DELIVERY OF ONE (1) UNIT FARM TRACTOR w/ ROTOVATOR (RCEF GOODS 20-11-13A)

WHEREAS, the Philippine Rice Research Institute posted the Invitation to Bid (ITB) on 10 December 2020 for the abovementioned project in PhilRice Website, and posted continuously for twenty (20) days, 10 to 29 December 2020 at G-EPS and conspicuous places at the premises of PhilRice pursuant to Section 21.2 of the revised IRR of RA 9184;

WHEREAS, only one (1) bid\$ was received and opened on 29 December 2020, and the same passed the preliminary evaluation of bids;

WHEREAS; the bid proposal of the hereunder bidder was found to be complying with the eligibility requirements;

To declare **ABOMAR Equipment Sales Corporation**, as the Bidder with the Single Calculated and Responsive Bid for the **SUPPLY and DELIVERY of One (1) Unit Farm Tractor with Rotovator under RCEF Goods 20-11-13A** in the total contract amount of **One Million Three Hundred Ninety Thousand Pesos only (P1,390,000.00)**;
- b. To recommend for approval by the Executive Director of the Philippine Rice Research Institute the foregoing findings.




