WHEREAS, the Philippine Rice Research Institute posted the Invitation to Bid (ITB) on 08 October 2020 for the abovementioned project in PhilRice Website, and posted continuously for twenty one (21) days, 08 to 28 October 2020 at G-EPS and conspicuous places at the premises of PhilRice pursuant to Section 21.2 of the revised IRR of RA 9184;

WHEREAS, only one (1) bid was received and opened on 28 October 2020, and the same passed the preliminary evaluation of bids;

WHEREAS; the bid proposal of the hereunder bidder was found to be complying with the eligibility requirements;

NOW, THEREFORE, we, the Members of the RCEF Bids and Awards Committee, hereby RESOLVE as follows:


- a. To declare two-failed bidding on the procurement of **Supply and Delivery of Educational Calendar under RCEF Goods 20-09-10A;**


