

INVITATION TO BID

SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) LOT MODULAR PARTITION WITH OFFICE FURNITURE FOR ADMIN, RCEF-BDD AND R&D OFFICE under PB 20-04-07

1. The **Philippine Rice Research Institute-Agusan Station**, through the **2020 Rice Competitiveness Enhancement Fund Budget** intends to apply the sum of **ONE MILLION FIVE HUNDRED THOUSAND PESOS ONLY (PhP 1,500,000.00)** being the ABC to payments under the contract for the **SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) LOT MODULAR PARTITION WITH OFFICE FURNITURE for ADMIN, RCEF-BDD AND R&D OFFICE under PB 20-04-07**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Rice Research Institute- Agusan Station** now invites bids for the above Procurement Project. Delivery of the Goods is required within the period specified in the Schedule of Requirements. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from PhilRice Agusan through telecommunication or video conferencing during office hours and inspect the Bidding Documents at the PhilGEPS website, kindly refer to the schedule below.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 27, 2020 to December 21, 2020** from the address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of **One Thousand Five Hundred Pesos Only (PhP 1,500.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that the bidders shall pay the applicable fee for Bidding Documents, which shall be open to prospective bidders.

6. The Philippine Rice Research Institute will hold a Pre-Bid Conference on **December 7, 2020, 09:00AM** at PhilRice Agusan, Basilisa, RTRomualdez, Agusan del Norte which shall be open to all prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 21, 2020 8:00AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 21, 2020; 9:00AM** at PhilRice Agusan, Basilisa, RTRomualdez, Agusan del Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Philippine Rice Research Institute-Agusan Station** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
