

**Invitation to Bid for the
Improvement of Maintenance Shed for Future Rice Farm, Repair Bay, Parking and Log Shed and
Replacement of Roofing of Farm Operation Unit (FOU) at PhilRice CES
(PB Infra 21-01-03)**

1. The **Philippine Rice Research Institute – Central Experiment Station**, through the **2021 Corporate Fund Budget** intends to apply the sum of **Two Million Fifty-Nine Thousand Seven Hundred Fourteen and 07/100 Pesos Only (Php 2,059,714.07)** being the Approved Budget for the Contract (ABC) to payment under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening with breakdown as follows:

Lot 1	Improvement of Maintenance Shed for Future Rice Farm	Four Hundred Ninety-Four Thousand and 00/100 Pesos Only (PhP494,000.00)
Lot 2	Improvement of Repair Bay, Parking and Log Shed	Five Hundred Eighty-Eight Thousand One Hundred Seventy-Seven & 19/100 Pesos Only (Php 588,177.19)
Lot 3	Replacement of Roofing of Farm Operation Unit Machinery Shed	Nine Hundred Seventy-Seven Thousand Five Hundred Thirty-Six and 88/110 Pesos Only (Php 977,536.88)

2. The **Philippine Rice Research Institute – Central Experiment Station** now invites contractors with PCAB license of at least **Category C & D/Small B** for the above Procurement Project. Completion of the Works is required **One Hundred Twenty Calendar Days (120 CD) for each lot**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from **PhilRice-Central Experiment Station** through telecommunication or video conferencing during office hours and inspect the Bidding Documents at the PhilGEPS and PhilRice websites. Kindly refer to the schedule below.
5. A complete set of Bidding Documents may be acquired by interested bidders from the address and websites below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWO THOUSAND ONE HUNDRED PESOS ONLY (PhP 2,100.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the deadline of submission of their bids.

Bidders are encouraged to download the Bidding Documents through the PhilGEPS or the PhilRice website and pay through bank. Please coordinate with the BAC Secretariat through the email address and contact number given below for the bank details and procedures.

6. The **Philippine Rice Research Institute – Central Experiment Station** will hold an online/virtual Pre-Bid Conference on the date specified below which shall be open to all prospective bidders.

Prospective bidders need to signify their intention to participate by sending an email to the address given below. A Personal Meeting ID will be sent through SMS or email for each participant at least one day before the event.

7. Bids must be duly received by the BAC Secretariat at the address below one (1) day before the opening of bids. through manual submission at the office address as indicated below.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

Face to face and online/virtual Bid opening shall be held on the given schedule below and bids will be opened in the presence of the bidders' representatives (limited number only) who choose to attend the activity. Late bids shall not be accepted.

The **Philippine Rice Research Institute- Central Experiment Station** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
