



INVITATION TO BID FOR THE PROCUREMENT OF VEHICLE RENTAL SERVICES WITH PROVISION FOR DRIVER UNDER PB 20-02-03

- 1. The Philippine Rice Research Institute, through the **2020 RCEP Fund Budget** intends to apply the sum of **ONE MILLION SIX HUNDRED TWENTY FIVE THOUSAND PESOS AND 00/100 ONLY (PhP 1,625,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Vehicle Rental Services with Provision for Driver under PB 20-02-03.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Rice Research Institute now invites bids for the **PROCUREMENT OF VEHICLE RENTAL SERVICES WITH PROVISION FOR DRIVER.** Delivery of the Goods is required within the period specified in the Schedule of Requirements. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from PhilRice and inspect the Bidding Documents at the address given below during office hours from 8:00AM to 5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 10, 2020 to May 4, 2020** from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by GPPB, in the amount of **One Thousand Seven Hundred Pesos and 00/100 (PhP1,700.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Philippine Rice Research Institute will hold a Pre-Bid Conference on **April 20**, **2020**, **2:00PM** at PhilRice Agusan, Basilisa, RTRomualdez, Agusan del Norte (*Online Pre-Bid Conference could be an option*), which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before **May 4**, **2020; 1:00PM.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **May 4**, **2020**; **2:00PM** at PhilRice Agusan, Basilisa, RTRomualdez, Agusan del Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The Philippine Rice Research Institute reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
