CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of January, 2021 between PHILIPPINE RICE RESEARCH INSTITUTE – AGUSAN EXPERIMENT STATION of the Philippines (hereinafter called "the Entity") of the one part and D. DOMINGO GASOLINE STATION of Brgy. Mabini, Cabadbaran City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply and Delivery of Fuel (Diesel & Gasoline) for the Year 2021 under PB 21-01-01 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million One Hundred Ninety-Two Thousand Four Hundred Thirty-Five Pesos and 10/100; PhP 1,192,435.10 (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto;and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

WHEREAS, the Philippine Rice Research Institute advertised the call for Public Bidding for the project Supply and Delivery of Fuel (Diesel & Gasoline) for the year 2021 under PB 21-01-01 which is an Early Procurement Activity with an ABC amounting to One Million Two Hundred Seventy-Six Thousand Two Hundred Pesos and 42/100 (PhP 1,276,200.42);

WHEREAS, in response to the aforesaid advertisement, D. Domingo Gasoline Station was the lone prospective bidder who purchased bidding document for the project on December 18, 2020 and submitted bid proposal on December 21, 2020 at 8:48AM;
