

SERVICE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement is made and entered by and between:

The **PHILIPPINE RICE RESEARCH INSTITUTE**, a government-owned and controlled corporation with office address at Brgy. Basilisa, RTRomualdez, Agusan del Norte, herein represented by **DR. CAESAR JOVENTINO M. TADO**, Branch Director, hereinafter referred to as "**PhilRice**";

-and-

The **FRC TRANSPORT SERVICE** with office address located at Brgy. Hubang San Francisco, Agusan del Sur, a legitimate entity engaged in land transportation for the transport and carriage of passengers, goods and merchandise within any place in the Philippines, herein represented by **MR. FERNANDO R. CURATO**, Proprietor, hereinafter referred to as "**FRC**";

PhilRice and FRC are hereinafter collectively referred to as "**Parties**".

-WITNESSETH-

Whereas, **PhilRice** in its enormous activities and its desirous intent to provide all out support for the employees and officers who are required to travel to conduct seed inspection, delivery and distribution; mobilization at LGUs; gather FSAR & QR Codes; and related activities in target provinces/municipalities of Region X, XI and XIII covered by RCEF for the period April 26-July 31, 2021, is in need of additional transportation services through vehicle rental;

Whereas, the **FRC** is ready, willing, able and has the capacity to efficiently perform the services as required and agrees to comply with PhilRice and government accounting and auditing rules;

NOW, THEREFORE, for and in consideration of the total amount not exceeding **SEVEN HUNDRED FOUR THOUSAND PESOS AND 00/100 (PhP 704,000.00)** for Lot 2, covering Region XI municipalities, payable upon presentation of the bill, with accomplished trip tickets submitted to PhilRice, the Parties have agreed to the following terms and conditions:

1. **FRC** shall deploy vehicles with driver and will render service to PhilRice as follows:
 - a. All vehicle must have franchise to operate in the above provinces (with LTO license "For Hire") and proof of LTFRB application or registration, whichever is available;
 - b. All vehicle should have a commuter type of seating, preferably a 12-seater van, which should not be more than 5 years from the date of purchase with comprehensive insurance;
 - c. The rate offers must be expressed in terms of daily rate basis, inclusive of VAT, driver's food, fuel cost, toll fees and parking fees and all applicable taxes and charges based on the submitted price quotation of the FRC (See **Annex A**). The Service Provider shall shoulder the board and lodging of their driver;
 - d. The drivers should wear uniforms, if any, or appropriate attire during travel;

- e. All vehicle must be equipped with complete early warning device, spare tires, tools, air-condition, seat belts and alcohol or any disinfectant spray;
 - f. Rental Company must provide "best effort basis" replacement units during accidents and repairs with the same class and same carrying capacity In this regard, a list of vehicles and drivers assigned is hereto attached as **Annex B**;
 - g. The procuring entity reserves the right to change schedule as needed, provided, that the winning bidder shall be afforded a notice within a justifiable period of time;
 - h. The allocated number of days per lot or Region are staggered basis, which shall not exceed to 15 consecutive days per travel. For instances, two or more vehicle may be required to be deployed simultaneously, within the same route, depending on the volume of the end-user's undertakings;
 - i. Point of origin will be at PhilRice Agusan, Basilisa, RTRomuladez, Agusan del Norte to any point in Region XI and/or those specified in the approved trip tickets as pick-up and drop off points;
 - j. Driver shall ensure that all passengers sign in the trip ticket;
2. Use of vehicle to be rented shall not exceed a continuous period of more than fifteen (15) days (Section 76 of EO 292) per travel;
 3. Disbursement of funds under this Agreement shall be in accordance with existing government accounting and auditing rules and regulations;
 4. Any violation of this Agreement; or if the **FRC** driver or official display and act of aggressive driving, discourtesy and ill manner or treatment to any PhilRice Staff, may result to cancellation of this Agreement. The FRC drivers and officials who have issues and complaints against passenger or PhilRice personnel should submit a formal notice to the GASS Coordinator at the following address:

5. If any term or condition of this Agreement is held invalid or contrary to law, the validity of the other terms and conditions shall not be affected hereby;
6. Effectivity of this Agreement is from the date of signing up to 31 July 2021 or until the Agreement amount has been consumed; and
7. All legal actions out of this Agreement shall be exclusively filed with the 1st Municipal Circuit Trial Court (Magallanes-Las Nieves-Remedios T. Romualdez) or the Regional Trial Court of Cabadbaran City, Agusan del Norte.

WHEREAS, on March 28, 2021, the Philippine Rice Research Institute – Agusan Experiment Station, advertised the call for Public Bidding for the project **Procurement of Vehicle Rental Services with provision for driver covering the period April 26-July 31, 2021 under PB AES 21-01-04** with an ABC amounting to One Million Nine Hundred Ninety-Eight Thousand Pesos and 00/100 (PhP 1,998,000.00) for 3 lots;

WHEREAS, in response to the aforesaid advertisement, there were five suppliers found in the Document Request List (DRL) of the station's PhilGEPs account, to wit: A-Five Car Rental, Voyagez Professionnel Incorporated, Lovely Century Transport Service, Big C Travel and Tours and Rockred Corporation;

WHEREAS, on April 5, 2021, the Bids and Awards Committee (BAC) held a Pre-Bid Conference that was attended by four (4) prospective bidders, viz.: Lovely Century Transport Service, Caraga Butuan Transport Service Cooperative, Agusan del Norte PUV Transport Service Cooperative and FRC Transport Service;

WHEREAS, on April 19, 2021 during the bid opening, there were two (2) prospective bidders who submitted bid proposal, viz.: Lovely Century Transport Service of Butuan City and FRC Transport Service of San Francisco, Agusan del Sur;

WHEREAS, Lovely Century Transport Service submitted a responsive bid proposal for Lot 1 amounting to Seven Hundred Four Thousand Pesos and 00/100 (PhP704,000.00) and for Lot 3 amounting to Five Hundred Ninety Thousand Pesos and 00/100 (PhP590,000.00), while FRC Transport Service submitted an equally responsive bid proposal for Lot 2 amounting to Seven Hundred Four Thousand Pesos and 00/100 (PhP704,000.00);

WHEREAS, on April 19, 2021, the BAC sent a letter request to Lovely Century Transport Service to submit a valid PhilGEPs Registration Certificate in lieu of the attached expired certificate and LBP On-Coll Receipt, as part of Post-qualification requirements, within five (5) calendar days upon receipt of notice which was received by the bidder on the same date;

WHEREAS, as of April 26, 2021, the BAC did not received a response from Lovely Century Transport Service, thus, the BAC issued a Notice of Post-Disqualification which was also received by the bidder on the same date;

WHEREAS, FRC Transport Service was rated **PASSED** and was declared **SINGLE RATED AND RESPONSIVE BID for Lot 2** amounting to Seven Hundred Four Thousand Pesos and 00/100 (PhP704,000.00);
