



INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF AGRICULTURAL SUPPLIES (FERTILIZERS AND PESTICIDES) PB 21-02-23

- 1. The **Philippine Rice Research Institute**, through the **2021 Trust Fund Budget** intends to apply the sum of **EIGHT HUNDRED FORTY NINE THOUSAND AND FOUR HUNDRED**
- 2. **PESOS ONLY (Php 849,400.00)** being the ABC to payments under the contract for the **SUPPLY AND DELIVERY OF AGRICULTURAL SUPPLIES (FERTILIZERS AND PESTICIDES) PB 21-02-23**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 3. The **Philippine Rice Research Institute** now invites bids for the above Procurement Project. Delivery of the Goods is required within the period specified in the Schedule of Requirements. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 5. Prospective Bidders may obtain further information from PhilRice through telecommunication or video conferencing during office hours and inspect the Bidding Documents at the PhilGEPS and PhilRice websites. (Kindly refer to the schedule below).
- 6. A complete set of Bidding Documents may be acquired by interested Bidders from the address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of **One Thousand Pesos Only (Php 1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either by facsimile, or through other electronic means.
 - We encourage bidders to download the bidding documents through PhilGEPS or the PhilRice website and pay through bank. Please coordinate with the BAC Secretariat through the email address and contact number given below for the bank details and procedure.
- 7. Bids must be duly received by the BAC Secretariat at the address below one (1) day before the opening of bids. (i) manual submission or through courier at the office address indicated below. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
 - Bid opening shall be on **July 02, 2021**; **9:00 AM** at the address given below via zoom.

Bids will be opened in the presence of the bidder's representatives who choose to attend the activity.
