

**BAC Resolution Recommending Award for the
Supply and Delivery of One (1) Unit Brand New Forklift for Business Development

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of one (1) unit Brand New Forklift for BDD (PB 21-01-18)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **March 04 to 24, 2021**;

WHEREAS, in response to the said advertisements, four (4) prospective bidders were listed in the PhilGEPS document request list, but only one (1) prospective bidder purchased the bidding documents and submitted proposal on time, **Powerlifter Phils. Inc.**;

WHEREAS, on March 24, 2021, Bid Bulletin no. 1 and on March 30, 2021, Bid Bulletin no. 2 for PB 21-01-18 were issued reflecting the changes in the schedule of the bidding activity (deadline and submission of bids);

WHEREAS, the total approved budget for the contract (ABC) is **One Million Five Hundred Fifty-One Thousand Eight Hundred Forty-Four and 48/100 Pesos Only (P 1,551,844.48)**;

WHEREAS, during the submission and opening of bids held last **April 14 and 15, 2021** respectively, **Powerlifter Phils. Inc.** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **Powerlifter Phils. Inc.** was found to be substantially complying and read as follows:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:


