**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of IT and Office Equipment PB 21-02-21** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **June 04 to 28, 2021**;

**WHEREAS**, in response to the said advertisements, ten (10) prospective bidders were listed in the PhilGEPS document request list, four (4) prospective bidders attended the Pre-bid conference but only one (1) bidder purchased the bidding document and submitted proposal on time, **S1 Technologies Inc.**;

**WHEREAS**, on 15 June 2021, Bid Bulletin no. 1 was issued reflecting the changes in the schedule of requirements;

**WHEREAS**, the total approved budget for the contract (ABC) is **Eight Hundred Twenty Five Thousand Three Hundred Ninety Two and 00/100 Pesos Only (P825,392.00)**;

**WHEREAS**, during the submission and opening of bids held last **28 June and 29 June, 2021** respectively, **S1 Technologies Inc.** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of **S1 Technologies Inc.** was found to be substantially complying and read as follows:




