  - b. Construction Safety and Health Manual Application duly received by the Department of Labor and Employment.
  - c. Construction Schedule & S-Curve
  - d. PERT-CPM
  - e. Manpower Utilization Schedule
  - f. Equipment Utilization Schedule
  - g. Construction Methods


