

**BAC Resolution Recommending Award for the
Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides)
PB 21-02-23**

**BAC RESOLUTION No. 24
Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) PB 21-02-23** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **June 23 to July 01, 2021**;

WHEREAS, in response to the said advertisements, three (3) prospective bidders were listed in the PhilGEPS document request list, but only one (1) bidder purchased the bidding document and submitted proposal on time, **YCC Enterprise, OPC.**;

WHEREAS, the total approved budget for the contract (ABC) is **Eight Hundred Forty Nine Thousand Four Hundred and 00/100 Pesos Only (P 849,400.00)**;

WHEREAS, during the submission and opening of bids held last **01 July** and **02 July, 2021** respectively, **YCC Enterprise, OPC** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **YCC Enterprise, OPC** was found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the result were as follows:

Item number 5,6,7,8	Offer of the lone bidder is complying with the required technical specifications and within the approved budget per item but the end-user preferred other brand not offered in the bid proposal.	Brands offered to be replaced by the end-user preferred brands except for item 5

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **AWARD** item numbers 1,2,3,4,6,7,8,9 and 10 for the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) PB 21-02-23 to YCC Enterprise, OPC** for being the single calculated and responsive bid;
- b) To **REVIEW** the budget for item number 5, then for re-canvass thru Alternative Method of Procurement;
- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.


