

**BAC Resolution Recommending Award for
Supply & Delivery of Various Molecular Biology Supplies (PB 21-01-06)**

**BAC RESOLUTION No. 03
Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply & Delivery of Various Molecular Biology Supplies PB 21-01-06** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **November 11 to December 01, 2020**;

WHEREAS, in response to the said advertisements, three (3) prospective bidders attended the Pre-Bid Conference but only two prospective bidders purchased the bidding documents and submitted proposals on time, 1) Noveaulab Asia Corp. and 2) Chemoscience Phils. Inc.;

WHEREAS, the **approved budget for this contract (ABC) is Five Hundred Eleven Thousand Nine Hundred Fifty Two and 00/100 Pesos Only (Php 511,952.00)**;

WHEREAS, on November 23, 2020, Bid Bulletin no. 1 for PB 21-01-06 was issued reflecting movement of schedule for the deadline of submission and opening of bids to December 04, 2020 and December 07, 2020, respectively;

WHEREAS, during the opening of bids held last December 07, 2020, **NOVEAULAB ASIA CORP. AND CHEMOSCIENCE PHILS. INC.** were both rated **PASSED** in the eligibility & technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **both bidders** were found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the results were as follows:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby RESOLVED:




