

**BAC Resolution Recommending Award for the
Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides)
(PB 21-01-14)**

**BAC RESOLUTION No. 06
Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) PB 21-01-14** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **January 15 to February 09, 2021**;

WHEREAS, in response to the said advertisements, two (2) prospective bidders were listed in the PhilGEPS document request list, but only one (1) prospective bidder purchased the bidding documents and submitted proposal on time, Binhi Producers Cooperative with business address at Door 3 CND Bldg. Nuñez St. Bantug Bulalo, Cabanatuan City.

WHEREAS, the total approved budget for the contract (ABC) is **Two Million Five Hundred Eighty-Eight Thousand Nine Hundred Seventeen and 92/100 Pesos Only (P 2,588,917.92)**;

WHEREAS, during the submission and opening of bids held last **February 09 and February 10, 2021** respectively, **Binhi Producers Cooperative** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **Binhi Producers Cooperative** was found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of Binhi Producers Cooperative successfully met all the legal, technical and financial document and technical specifications required.

WHEREAS, during the evaluation of the Abstract of Bids by the End-user upon verification of the item requested in the Purchase Request submitted, they have found out that the requested 610 bags of Complete (Item no. 80) were mistakenly requested, and therefore requesting for approval of cancellation of the said item.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:


- To **AWARD** the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) PB 21-01-14** except item no. 80 to **Binhi Producers Cooperative** for being the single calculated rated and responsive bid;
- To **CANCEL** item no. 80 in the Abstract of Bid and to not include in the awarding as requested by the end user;
- To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
