



**BAC RESOLUTION DECLARING FAILURE OF BIDDING
OF THE PROJECT:
SUPPLY & DELIVERY OF VARIOUS AGRICULTURAL INPUTS FOR PHILRICE CMU 2022
DRY CROPPING SEASON**

**RESOLUTION No. 15

WHEREAS, on September 24, 2021, the Philippine Rice Research Institute – Agusan Experiment Station, advertised the call for bidding for the project **Supply & Delivery of various Agricultural Inputs for PhilRice CMU 2022 Dry Cropping Season under PB AES 21-04-08** with an ABC amounting to One Million Seven Hundred Sixteen Thousand Fifty and 00/100 Pesos (PhP 1,716,050.00);

WHEREAS, on October 21, 2021, the Bids and Awards Committee (BAC) held a Pre-Bid Conference which was attended by a lone prospective bidder, the Goodfarms Trading Corporation of Don Carlos, Bukidnon;

WHEREAS, on November 1, 2021 at 5:00PM, the deadline for submission of bid proposal, there was no bid proposal received by the BAC Secretariat of PhilRice Agusan at Basilisa, RTRomualdez, Agusan del Norte, thus, the BAC decided to conduct the bid opening at PhilRice Agusan instead of PhilRice CMU;

WHEREAS, on November 2, 2021, the scheduled bid opening for the project, it was re-affirmed by the TWG - Agricultural Inputs of PhilRice CMU, that there was also no bid proposal received by PhilRice CMU Field Office at Musuan, Maramag, Bukidnon;

WHEREAS, Section 35.1 (b) of the Revised IRR of RA No. 9184 provides, “The BAC shall declare the bidding a failure when:

a) No bids are received;

WHEREAS, as a result of the failure of bid, the BAC conducted a mandatory review and evaluation of the project pursuant to Section 35.2 of the Revised IRR of RA9184.

WHEREAS, the during the mandatory review, BAC & TWG identified the major factor for the failed bidding, which is the sudden price escalation of fertilizers in the market as per feedback from their previous suppliers;

WHEREAS, Mandatory Review Report disclosed that there were several agricultural inputs which are urgently needed by PhilRice CMU within the first three (3) weeks of crop establishment (November 2nd week – 1st week of December 2021), viz:

- a) 50 bags – Ammonium Sulfate (21-0-0-24S)
- b) 50 bags – Complete (14-14-14)
- c) 45 boxes - Nicrozamide, 700g/kg (1000g)
- d) 15 gallon – Glyphosate
- e) 40 bottle – Butachlor 360g/L + 2,4-D 240g/L (1000ml)
- f) 5 bottle – 2,4-D (phenoxy compound), (as iso-octyl ester), 500g/L (1000ml)






WHEREAS, in view of the urgency of need to immediately procure several agricultural inputs to be used during the first three (3) weeks of crop establishment, it was unanimously agreed to procure the aforesaid items thru Small Value Procurement.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To **DECLARE** failure of bidding for the project, Supply and Delivery of various Agricultural Inputs for PhilRice CMU 2022 Dry Cropping Season under PB AES 21-04-08;
2. To **RECOMMEND** for immediate procurement of the above-enumerated items in a separate Purchase Request under Small Value Procurement;
3. To **RECOMMEND** for a preparation of a new Purchase Request for the remaining agricultural inputs to be procured under Public Bidding, based on adjusted quantity and updated prices, to deter another failure of bidding;
4. To **RECOMMEND** for approval by the Branch Director, the foregoing findings.
