



**BAC Resolution Declaring LCRB and Award for the Commercial Printing and Delivery of RCEF 2022 Educational Calendar for Luzon Cluster (RCEF Goods 21-04-04)**

**BAC RESOLUTION No. 05 Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Commercial Printing and Delivery of RCEF 2022 Educational Calendar for Luzon Cluster (RCEF Goods 21-04-04)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **April 30, 2021 to May 25, 2021** with an **approved budget of the contract (ABC)** amounting to **Seven Million Nine Hundred Seventy-Two Thousand Five Hundred Pesos Only (P 7,972,500.00)**;

WHEREAS, on May 14, 2021, **Bid Bulletin no. 1** for RCEF Goods 21-04-04 was issued reflecting the changes in Section I. Invitation to Bid, and Section VII. Technical Specification;

WHEREAS, in response to the said advertisements, eighteen (18) prospective bidders viewed the advertisement in the PhilGEPS reflected in document request list, however only six (6) prospective bidders purchased the bidding documents and submitted proposal on time namely 1) **GA Printing Inc.**, 2) **Haus of Serah Printing and Trading Corp.**, 3) **Cover and Pages Corporation** 4) **Knit & Tuck Merchandising** 5) **Rapid Printing** & 6) **Kasapi-Kaagapay Marketing Corp.**;

WHEREAS, during the opening of bids held last May 25, 2021, **the above mentioned six (6) prospective bidders** were rated **PASSED** in the eligibility & technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **the six (6) bidders** were found to be substantially complying and read as follows:




