

**BAC Resolution Declaring LCRB and Award for the  
Procurement of Desktop Rental  
(RCEF Goods 21-06-07)**

**BAC RESOLUTION No. 08 Series of 2021**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Procurement of Desktop Rental (RCEF Goods 21-06-07)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **June 19, 2021 to July 13, 2021** with an **approved budget of the contract (ABC)** amounting to **Two Million Three Hundred Thousand Pesos Only (P2, 300,000.00)**;

WHEREAS, on July 05, 2021, **Bid Bulletin no. 1** for RCEF Goods 21-06-07 was issued reflecting the changes in Sections III, VI & VII; Bid Data Sheet, Schedule of Requirement, and Technical Specifications;

WHEREAS, in response to the said advertisements, eight (8) prospective bidders viewed the advertisement in the PhilGEPS reflected in document request list, however only two (2) prospective bidders purchased the bidding documents and submitted proposal on time namely 1) **S1 Technologies, Inc** and 2) **Hundredfold Trading Corp.**;

WHEREAS, during the opening of bids held last July 13, 2021, **the above mentioned two (2) prospective bidders** were rated **PASSED** in the eligibility & technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **the two (2) bidders** were found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation **dated July 13 to August 02, 2021**, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, **Hundredfold Trading Corp.**, as the Lowest Calculated and Responsive Bidder (LCRB) has found to be **RESPONSIVE**:

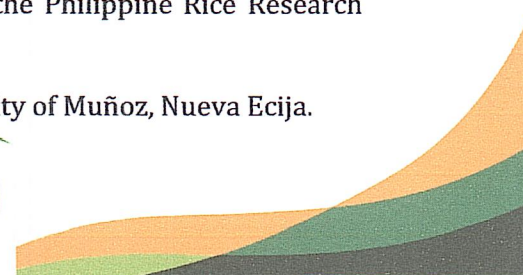
NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:
