



**BAC Resolution Declaring LCRB and Award for the
Commercial Printing and Delivery of 3 Folds (4 Panels) Brochure

(RCEF Goods 21-08-10)**

BAC RESOLUTION No. 11 Series of 2021

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Commercial Printing and Delivery of 3 Folds (4 Panels) Brochure for Visayas Cluster (RCEF Goods 21-08-10)** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **August 4 -26, 2021** with an **approved budget of the contract (ABC)** amounting to **One Million Five Hundred Sixty-Six Thousand and Five Hundred Pesos Only (1,566,500.00)**;

WHEREAS, on August 20, 2021, **Bid Bulletin no. 1** for RCEF Goods 21-08-10 was issued reflecting the changes in Sections I, VI and VII; Invitation to Bid, Schedule of Requirements and Technical Specifications;

WHEREAS, in response to the said advertisements, fifteen (15) prospective bidders viewed the advertisement in the PhilGEPS reflected in document request list, however only four (4) prospective bidders purchased the bidding documents and submitted proposal on time namely 1) **Knit and Tuck Merchandising** 2) **Cover and Pages Corporation** 3) **E and A Inkpress Prints and Enterprises** and 4) **Innovation Printshoppe**;

WHEREAS, during the opening of bids held last August 26, 2021, **the above mentioned four (4) prospective bidders** were rated **PASSED** in the eligibility & technical requirements and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of **the four (4) bidders** were found to be substantially complying. Arranged from lowest to highest bidder and read as follows:

- a) To declare **Knit and Tuck Enterprises** as the **LCRB** for the **Commercial Printing and Delivery of 3 Folds (4 Panels) Brochure for Viasayas Cluster RCEF Goods 21-08-10** in the total contract amount of **One Million Two Hundred Thirty-Six Thousand Three Hundred Thirty Pesos Only (Php 1,236,330.00)**;


- b) To **RECOMMEND** for approval by the Executive Director of the Philippine Rice Research Institute the foregoing findings.
