



# BAC RESOLUTION RECOMMENDING AWARD FOR THE ROAD CONCRETING FROM RESEARCH BUILDING TO MOTORPOOL, TOLL GATE AND ADMINISTRATION BUILDING

# **PB AES INFRA 21-03-01**

# RESOLUTION No. 14 Series of 2021

WHEREAS, on 24 September 2021, the Philippine Rice Research Institute advertised the call for bidding for the project Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building under PB AES INFRA 21-03-01 with an ABC amounting to One Million Nine Hundred Ninety-Nine Thousand Eight Hundred Forty-Three and 13/100 Pesos (PhP1,999,843.13);

**WHEREAS**, in response to the aforesaid advertisement, there were three (3) bidders found in the Document Request List (DRL) of PhilGEPS;

**WHEREAS**, on 04 October 2021, the Bids and Awards Committee (BAC) Member and TWG – Infra projects convened for the scheduled Pre-Bid Conference;

**WHEREAS**, there were seven (7) prospective bidders who purchased the bidding document for the project but only five (5) bidders subsequently submitted bid proposal for the project within the prescribed timeline, viz: Ramjequo Construction and Supply, LGC Construction & Supply, C&R Construction and Supply, Poliran Builders Corporation, and Grandstellar Builder's Inc.;

**WHEREAS**, during the bid opening on 18 October 2021, the Bid Proposals of the five (5) bidders were examined and all of the bidders were rated Passed and declared Eligible as per its eligibility and technical components (First Envelope);

**WHEREAS**, the Financial Proposal of the bidders were opened and read and will be subject for detailed evaluation to objectively consider the completeness of the bid and arithmetical corrections, as follows:

**WHEREAS**, the TWG-Infrastructure projects presented its Comparative Analysis and report to the BAC (copy hereto attached), and accordingly recommended the following:

"After careful evaluation and scrutinization of the data presented, the undersigned is hereby reporting the following findings: 1) LGC Construction & Supply has an As Calculated amount of Php2,030,890.33 which deviates from













their reflected bid amount in the bid form which is Php1,999,416.75. That being said, the former amount will prevail and shall be the basis for their Final Bid Amount; 2) C&R Construction and Supply has no material cost for the item Concrete Works and therefore is Non-Compliant to the prescribed requirements set by PhilRice; and 3) Ramjequo Construction and Supply has the Lowest Calculated Responsive Bid."

**WHEREAS**, on 21 October 2021, the TWG and selected BAC members, conducted a Post-Qualification to verify, validate and ascertain the authenticity and genuineness of all statements and documents submitted by Ramjequo Construction and Supply, pursuant to Section 34 of the Revised IRR of RA 9184;

**WHEREAS**, upon careful examination and evaluation of all the documents submitted and after post-qualification, **Ramjequo Construction and Supply** of Brgy. Marcos, Magallanes, Agusan del Norte was declared as the bidder who has the **LOWEST CALCULATED & RESPONSIVE BID** for the project.

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby RESOLVED:

- To AWARD the project Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building under PB AES INFRA 21-03-01 to RAMJEQUO CONSTRUCTION AND SUPPLY of Brgy. Marcos, Magallanes, Agusan del Norte in the amount of ONE MILLION FIVE HUNDRED NINETY-FOUR THOUSAND NINE HUNDRED NINETY-EIGHT AND 72/100 PESOS ONLY (PHP1,594,998.72); and
- 2. To **RECOMMEND** for approval by the Branch Director, the foregoing findings.

The coverage of work shall be as provided for in the bid tenders/documents issued by this office not withstanding any errors on the drawings or the specifications or underestimate in the quantities and values of work thereat; therefore, any item overlooked in the Bill of Quantities shall be furnished by the Contractor at no cost to PhilRice; and

- Performance Bond in the form of Surety Bond (with Insurance Commission Certificate), Bank Guarantee or a Cash Bond equivalent to 30% or 10%, respectively, of the project cost;

- f. Equipment Utilization Schedule;
- g. Construction Methods.

# **CONSTRUCTION CONTRACT**

### KNOW ALL MEN BY THESE PRESENTS:

This Construction Contract (Contract) made and entered into by and between:

The PHILIPPINE RICE RESEARCH INSTITUTE, a government-owned and controlled corporation created by virtue of Executive Order No. 1061, with its Central Experiment Station at Maligaya, Science City of Muñoz, Nueva Ecija, represented herein by its Branch Director (Agusan Experiment Station), CAESAR JOVENTINO M. TADO, hereinafter referred to as "PHILRICE":

- and -

The **RAMJEQUO CONSTRUCTION AND SUPPLY**, a duly licensed construction firm with office address at Brgy. Marcos, Magallanes, Agusan del Norte, represented, herein by its Proprietor, **JEQUOPA REY JARY O. MONDEJAR**, herein after referred to as "CONTRACTOR".

### WITNESSETH:

WHEREAS, a public bidding was held on 18 October 2021, at PhilRice Agusan, Basilisa, Remedios T. Romualdez, Agusan del Norte, for the project: "Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building" at PhilRice Agusan Experiment Station under Public Bidding No. PB AES INFRA 21-03-01.

WHEREAS, the Bids and Awards Committee recommended to the Branch Director that the project shall be awarded to the CONTRACTOR, its offer being the most advantageous to the Philippine Government;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree as follows:

- 1. The CONTRACTOR, in consideration of the sum ONE MILLION FIVE HUNDRED NINETY-FOUR THOUSAND NINE HUNDRED NINETY-EIGHT AND 72/100 PESOS ONLY (PHP1,594,998.72), payable based on progress billing for actual work completed and approved by the Owner's Representative/s, shall pursue and deliver to PHILRICE the project entitled "Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building" at PhilRice Agusan Experiment Station under Public Bidding No. PB AES INFRA 21-03-01 located at PhilRice Agusan, Basilisa, Remedios T. Romualdez, Agusan del Norte, as described in the Bid Documents and summarized in Annex "A", within SIXTY-FIVE CALENDAR DAYS (65 CD).
- 2. The minimum facilities required by the Building Code, the Fire Code, the Sanitation Code and other relevant Codes which have not been properly reflected in the Request for Quotation, shall nevertheless, be provided by the CONTRACTOR at no additional cost to PHILRICE.
- 3. In the implementation of the project, the CONTRACTOR shall perform his obligations as an independent contractor with sufficient tools, equipment, and workers. This Contract does not establish an employer-employee relationship between PHILRICE and the CONTRACTOR and his workers.
- 4. The provisions of RA 9184 and its IRR, shall govern and are deemed written into this Contract. In addition to any of the causes for termination of this Contract as provided for in RA 9184 and its Implementing Rules and Regulations, and the Bid

Documents, any of the following shall also constitute as sufficient ground for the termination of this Contract by PHILRICE:

- a) Failure to comply and strictly observe the Labor Code and the Social Security System requirements.
- b) Failure to submit to PHILRICE a bio-data of each of the Contractor's personnel complete with their pictures and their usual signatures and fingerprints before deployment, and failure of his workers to wear identification cards at all times while inside the PHILRICE premises.
- c) Giving or promising to give any money or gift to any official or employee of PHILRICE to secure and implement this Contract.
- d) Non-compliance or non-conformance with the Integrated Management System (IMS) and Intellectual Property Policies of PHILRICE.
- e) Conduct or behavior constituting infractions, offenses, felonies or other crimes by the Contractor or his workers, against PHILRICE and its employees, and third parties while inside the PHILRICE Compound, such as but not limited to taking out any materials, supplies, utilities, or garbage.
- 5. Disbursement of funds under this Contract shall be in accordance with the existing government accounting and auditing rules and regulations.
- 6. The exclusive venue of any action arising from this Contract shall be the 1st Municipal Circuit Trial Court (Magallanes-Las Nieves-Remedios T. Romualdez) or the Regional Trial Court of Cabadbaran City, Agusan del Norte.



# ANNEX "A" Summary of Expected Outputs in the Project

"Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building (PB AES INFRA 21-03-01)" at PhilRice Agusan Experiment Station

#### I. GENERAL

The facilities shall present itself as beautiful and sturdy structures with excellent finishing and high-quality workmanship, fully functional, useful and free from any defect or substandard materials and with conformance to specified quality that PhilRice requires.

# II. SITEWORK

All materials, equipment and other facilities necessary to be used in the site work shall be prepared before starting the work. All obstructions and physical hindrances shall be removed from the project site. However, preservation of natural elements (i.e., trees and plants beside or along the project area shall be, as much as possible, maximized and preserved.)

### III. CIVIL WORKS

The work includes, but is not limited to, the following: Road Concreting from Research Building to Motorpool, Toll Gate and Administration Building

### General

- 1. Cleaning and clearing of site. Upon completion, the temporary facility, right of way, borrow pits, and all ground occupied by the contractor in connection with the work shall be removed and cleaned of all excess materials, operation of the structure ready for use; and
- 2. Compliance to the Integrated Management System (IMS) Policy of PhilRice.
