WHEREAS, the Philippine Rice Research Institute- Bicol Station advertised the call for bidding for the **Provision of One (1) Lot Security Services for DA-PhilRice Bicol and DA-PhilRice Samar Satellite Station under (PB21-11-01)** in the DA-PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **November 26 to December 20, 2021;**

WHEREAS, in response to the said advertisements, two (2) prospective bidders were listed in the PhilGEPS document request list, but only one (1) prospective bidder attended the Pre-bid conference held last December 06, 2021;

WHEREAS, the **approved budget for this contract (ABC) is One Million Six Hundred Thousand Pesos Only (Php 1,600,000.00);**

WHEREAS, on December 10 and 13, 2021, **Bid Bulletin No. 1 and 2** were issued reflecting clarification in the Invitation to Bid and an Addendum in the Schedule of Requirements and Technical specifications respectively;

WHEREAS, in response to the said advertisements, there was one (1) bidder who purchased the bidding document and submitted its bid proposal on time: **Topbest Security Agency Inc.;**

WHEREAS, during the opening of bids held last December 20, 2021, the abovementioned bidder was rated **PASSED** in the eligibility and technical requirements and declared to be **ELIGIBLE;**


