BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS AGRICULTURAL INPUTS

PB AES NO. 22-01-02

WHEREAS, the Philippine Rice Research Institute advertised the call for Public Bidding for the project **Supply and Delivery of various Agricultural Inputs under PB AES 22-01-02** which is an Early Procurement Activity with an ABC amounting to Nine Hundred Forty-Two Thousand Three Hundred Nine Pesos and 00/100 (PhP 942,309.00);

WHEREAS, on December 17, 2021, the supposed schedule of Pre-bid Conference for the project, said activity was postponed due to absence of electricity, mobile networks and internet connection and other constraints as a result of Typhoon Odette (PE issued Bid Bulletin No. 1);

WHEREAS, on December 29, 2021, there was no bid proposal received by the BAC Secretariat or the Procuring Entity within the prescribed timeline;

WHEREAS, Section 35.1 (b) of the Revised IRR of RA No. 9184 provides, "The BAC shall declare the bidding a failure when:

a) *No bids are received;*

WHEREAS, as a result of the failure of bid, the BAC conducted a mandatory review and evaluation of the project pursuant to Section 35.2 of the Revised IRR of RA9184.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To **DECLARE** failure of bidding for the project, Supply and Delivery of various Agricultural Inputs under PB AES 22-01-02;

2. To **RECOMMEND** for the immediate reposting of the project in PhilGEPS website.


3. To **RECOMMEND** for approval by the Branch Director, the foregoing findings.
