

**BAC Resolution Recommending Award for the  
Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) for PhilRice  
CES PB 22-01-08**

**BAC RESOLUTION No. 06  
Series of 2022**

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) for PhilRice CES PB 22-01-08** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **January 07 to 31, 2022**;

**WHEREAS**, the total approved budget for the contract (ABC) is **One Million Six Hundred Fifty-Six Thousand Nine Hundred Thirty and 00/100 Pesos Only (P1,656,930.00)**;

**WHEREAS**, in response to the said advertisements, two (2) prospective bidders were listed in the PhilGEPS document request list: VG Multi-Products Enterprises, and Farmvest Agrivet Trading;

**WHEREAS**, a Pre-Bid Conference was conducted last 17 January 2022 at 9 o'clock in the morning and attended by three (3) prospective bidders: Farmvest Agrivet Trading, YCC Enterprise, OPC and Aljay Agro industrial Solutions Inc.;

**WHEREAS**, only **YCC Enterprise, OPC** purchased the bidding document and submitted proposal before the set deadline;

**WHEREAS**, during the submission and opening of bids held last **31 January** and **02 February, 2022** respectively, **YCC Enterprise, OPC** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of **YCC Enterprise, OPC** was found to be substantially complying and read as follows:

**WHEREAS**, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of the lone bidder, **YCC Enterprise, OPC** successfully met all the legal, technical and financial document required.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- To **AWARD** item nos. 1,2,3,4,5,7,8,9,10,11,12,13,15,16,17,18,19,20 and 21 for the **Supply and Delivery of Agricultural Supplies (Fertilizers and Pesticides) for PhilRice CES PB 22-01-08** to **YCC Enterprise, OPC** for being the single calculated and responsive bid;

- b) To **RE-CANVASS** the two (2) items without bid, item numbers **6** and **14** and to be procured through Negotiated Procurement – Small Value Procurement;
- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
