



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES FOR MODULE 2 RICE SPECIALISTS' TRAINING COURSE (RSTC) – 2022 BATCH 1

RESOLUTION No. 6 Series of 2022

WHEREAS, on February 3, 2022, the Philippine Rice Research Institute advertised the call for Public Bidding for the project Procurement of Catering Services for Module 2 Rice Specialists' Training Course (RSTC) – 2022 Batch 1 under PB AES 22-01-06 with an ABC amounting to Two Million Two Hundred Seventy-Six Thousand Eight Hundred Pesos and 00/100 (PhP2,276,800.00);

WHEREAS, in response to the aforesaid advertisement, there was only two (2) bidders found in the Document Request List (DRL) of PhilGEPS, viz: Homer Catering Services and Butuan Grand Palace Hotel;

WHEREAS, on February 14, 2022, the Bids and Awards Committee (BAC) and TWG – Catering Services convened for the scheduled Pre-Bid Conference;

WHEREAS, there were two (2) prospective bidders who purchased the bidding document for the project and subsequently submitted bid proposal for the project, viz: Homer Catering Services and Jelai and Twin Store;

WHEREAS, on February 28, 2022, during the opening of bids, Jelai & Twin Store of Poblacion 1, RTRomualdez, Agusan del Norte and Homer Catering Services of Butuan City were rated Passed as per its eligibility and technical components;

WHEREAS, the bid proposal of Jelai & Twin Store was read as One Million Seven Hundred Twenty-Six Thousand Sixty Pesos and 00/100 (PhP1,726,060.00) while the bid of Homer Catering Services of Butuan City was read as Two Million One Hundred Forty-Nine Thousand Two Hundred Pesos and 00/100 (PhP2,149,200.00);

WHEREAS, upon careful examination and evaluation of all the documents submitted for the bidding, Jelai & Twin Store was declared as the bidder who has the **LOWEST CALCULATED & RESPONSIVE BID** for the project.











NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVED:

CONTRACT AGREEMENT

THIS AGREEMENT made the <u>10TH</u> day of <u>March</u>, 2022 between **PHILIPPINE RICE RESEARCH INSTITUTE – AGUSAN** of the Philippines (hereinafter called "the Procuring Entity") of the one part and **JELAI AND TWIN STORE** of Poblacion 1, RTRomualdez, Agusan del Norte, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of Catering Services for Module 2 Rice Specialists' Training Course (RSTC) – 2022 Batch 1 under PB AES 22-01-06** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Seven Hundred Twenty-Six Thousand Sixty Pesos and 00/100** (**PhP1,726,060.00**) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of One Million Seven Hundred Twenty- Six Thousand Sixty Pesos and 00/100 (PhP1,726,060.00) or such other sums as may be ascertained, Jelai And Twin Store agrees to deliver the Procurement of Catering Services for Module 2 Rice Specialists' Training Course (RSTC) 2022 Batch 1 under PB AES 22-01-06 in accordance with his/her/its Bid.
- 4. The Philippine Rice Research Institute Agusan agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. The Procuring Entity reserves the rights to regulate the quantity of the goods & services to be delivered depending on the actual number of training participants.
- Any dispute arising out of this contract shall exclusively be brought before the 1st Municipal Circuit Trial Court (Magallanes-Las Nieves-Remedios T. Romualdez) or the Regional Trial Court of Cabadbaran City, Agusan del Norte.
