



**BAC RESOLUTION RECOMMENDING AWARD FOR THE  
SUPPLY AND DELIVERY OF AGRICULTURAL SUPPLIES FOR BUSINESS  
DEVELOPEMENT DIVISION PB 22-01-10**

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Agricultural Supplies for Business Development Division PB 22-01-10** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **March 30 to April 18, 2022**;

**WHEREAS**, the total approved budget for the contract (ABC) is **Two Million Six Hundred Thousand Six Hundred One Pesos Only (P2,600,601.00)**;

**WHEREAS**, in response to the said advertisements, two (2) prospective bidders were listed in the PhilGEPS document request list namely: YCC Enterprise, OPC and The Big Box Idepot, Inc.;

**WHEREAS**, a Pre-Bid Conference was conducted last 06 April 2022 at 2 o'clock in the afternoon and attended by two (2) prospective bidders: YCC Enterprise, OPC and Aljay Agro Industrial Solutions Inc.;

**WHEREAS**, only one (1) bidder, YCC Enterprise, OPC purchased the bidding document and submitted proposal before the set deadline;

**WHEREAS**, during the submission and opening of bids held last **18 April** and **19 April, 2022** respectively, **the lone bidder** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of **aforementioned bidder** was found to be substantially complying and read as follows:

**WHEREAS**, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of YCC Enterprise, OPC, successfully met all the legal, technical and financial document required;

**WHEREAS**, during the post-qualification evaluation, the results of the evaluation were as follows:

Item numbers 3,4,5,7 and 10	Offered brand of the lone bidder is within the approved budget but end-user requested for other brands based on previous usage and tested with good quality.	Request to offer alternative brand for approval of end-user before award.


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:


