**WHEREAS**, the Philippine Rice Research Institute advertised the call for Public Bidding for the project **Supply and Delivery of Various Agricultural Inputs for 2022WS of PhilRice CMU under PB AES 22-02-08** with an ABC amounting to Two Million Two Hundred Eighty-Three Thousand Five Hundred Pesos and 00/100 (PhP 2,283,500.00);

**WHEREAS**, in response to the aforesaid advertisement, there were three (3) bidders found in the Document Request List (DRL) of PhilGEPS, viz: YCC Enterprise; Modern Time Enterprises Inc. and J-777 Agri Marketing Corp.;

**WHEREAS**, on May 6, 2022 at 08:00AM, the BAC convened for the Pre-Bid Conference of the project, with the virtual attendance of TWG - Agri. Inputs of PhilRice CMU, End-user/s and representative of Northern Agro, Inc., one of the prospective bidder/s;

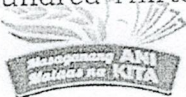
**WHEREAS**, there were two (2) prospective bidders who purchased the bidding document for the project and subsequently submitted bid proposal within the prescribed timeline for the project, viz: Northern Agro. Inc and Jeel's Masagana Farm Supply, Inc;

**WHEREAS**, on May 19, 2022 at 9:00AM, the BAC convened at PhilRice CMU Field Office for the bid opening and thoroughly examined the bid proposal of the two prospective bidders;

**WHEREAS**, during the opening of bids, Northern Agro, Inc. of Jose Abad Santos St., Kidapawan City, Cotabato and Jeel's Masagana Farm Supply, Inc. of Ochoa Corner J. Satorre St., Butuan City were rated **Passed** as per its eligibility and technical components;

**WHEREAS**, the bid proposal of Northern Agro, Inc. of Kidapawan City was read as One Million Nine Hundred Seventy-Eight Thousand Three Hundred Forty-Five Pesos and 00/100 (PhP1,978,345.00) while the bid of Jeel's Masagana Farm Supply, Inc. was read as Two Million Two Hundred Seventy-Five Thousand Five Hundred Thirteen Pesos and 90/100 (PhP2,275,513.90);





2. To **RECOMMEND** for approval by the Branch Director, the foregoing findings.







## CONTRACT AGREEMENT

THIS AGREEMENT made the \_\_\_\_\_ day of June 2022 between **PHILIPPINE RICE RESEARCH INSTITUTE - FIELD OFFICE CMU** of the Philippines (hereinafter called "the Entity") of the one part and **NORTHERN AGRO, INC.** of Jose Abad Santos St., Kidapawan City, North Cotabato, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Supply and Delivery of various Agricultural Inputs for 2022WS of PhilRice CMU under PB AES 22-02-08** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Nine Hundred Seventy Eight Thousand Three Hundred Forty Five Pesos; P1,978,345.00** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



- 3. In consideration for the sum of of **One Million Nine Hundred Seventy Eight Thousand Three Hundred Forty Five Pesos; P1,978,345.00** or such other sums as may be ascertained, **Northern Agro, Inc.** agrees to **Supply and Deliver various Agricultural Inputs for 2022WS of PhilRice CMU under BDD22-06-037** in accordance with his/her/its Bid.
- 4. The Philippine Rice Research Institute Field Office CMU agrees to pay the above mentioned sum in accordance with the terms of the Bidding.
- 5. Any dispute arising out of this contract shall exclusively be brought before the 1<sup>st</sup> Municipal Circuit Trial Court of Valencia City or the Regional Trial Court of Malaybalay City, Bukidnon.






