



**BAC RESOLUTION RECOMMENDING AWARD FOR THE
SUPPLY AND DELIVERY OF ONE (1) UNIT MOTOR VEHICLE FOR PHILRICE CES
PB 22-02-13**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of One (1) unit Motor Vehicle for PhilRice CES PB 22-02-13** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **May 26 to June 15, 2022**;

WHEREAS, the total approved budget for the contract (ABC) is **One Million Four Hundred Thousand Pesos Only (P1,400,000.00)**;

WHEREAS, in response to the said advertisements, six (6) prospective bidders were listed in the PhilGEPS document request list namely: Genesis Auto Corp., Manindra Auto Corp. (Foton Isabela), Nissan Commonwealth Inc., Manindra Auto Corp, The Legacy Trucks and Tractors Inc., and Areza Motor Sales;

WHEREAS, a Pre-Bid Conference was conducted last 03 June 2022 at 2 o'clock in the afternoon and attended by one (1) prospective bidder, Toyota Nueva Ecija, Inc.;

WHEREAS, Toyota Nueva Ecija Inc. purchased the bidding document and submitted proposal before the set deadline;

WHEREAS, during the submission and opening of bids held last **15 June** and **16 June, 2022** respectively, **all bidders** were rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of the **lone bidder** was found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the lone bidder, Toyota Nueva Ecija, Inc., passed the legal, technical and financial document required;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- To **AWARD** the **Supply and Delivery of one (1) unit Motor Vehicle for PhilRice CES PB 22-02-13** to **Toyota Nueva Ecija, Inc.** for being the **Single Calculated and Responsive Bid (SCRB)**;
- To **AWARD** to **Toyota Nueva Ecija Inc.** in the amount of One Million Three Hundred Ninety-Five Thousand and Seven Hundred Pesos Only (P 1,395,700.00);
