



**BAC Resolution Recommending Award for the
Supply and Delivery of Meals and Snacks for the conduct of Rice Specialist Training
Course, Farmer's Field School and Field Days on July to September 2022 (Framework
Agreement) under PB22-05-02**

**BAC RESOLUTION No. 04
Series of 2022**

WHEREAS, the Philippine Rice Research Institute- Bicol Station advertised the call for bidding for the **Supply and Delivery of Meals and Snacks for the conduct of Rice Specialist Training Course, Farmer's Field School and Field Days on July to September 2022 (Framework Agreement) under PB22-05-02** in the DA-PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **June 6 to 27, 2022;**

WHEREAS, the **approved budget for this contract (ABC) is Two Million Seven Hundred Nine Thousand Pesos Only (Php 2,709,000.00);**

WHEREAS, in response to the said advertisements, no bidders were listed in the PhilGEPS document request list;

WHEREAS, a Pre-Bid Conference was conducted last June 14, 2022 and attended by only one (1) prospective bidder, La Terraza Restaurant;

WHEREAS, there were two (2) bidders who purchased the bidding documents and submitted their bid proposals on the set deadline: **La Terraza Restaurant and Claire's Resto and Catering;**

WHEREAS, during the opening of bids held last June 27, 2022, Claire's Resto and Catering was rated **FAILED** after opening of the 1st envelope due to failure to include Conformity with technical specifications, as enumerated and specified in Section VI and VII of the bidding Documents and not meeting the required Single Largest Completed Contract (SLCC) similar to the contract to be bid;

WHEREAS, the remaining bidder La Terraza Restaurant was rated **PASSED** in the eligibility and technical requirements and declared to be **ELIGIBLE;**

WHEREAS, the financial proposal of **La Terraza Restaurant** was found to be substantially complying and read as follows:


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby RESOLVED:


