

## BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT PB 22-02-14

### BAC RESOLUTION No. 13 Series of 2022

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of ICT Equipment for PhilRice CES PB 22-02-14** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **May 26 to June 15, 2022**;

**WHEREAS**, the total approved budget for the contract (ABC) is **One Million Four Hundred Eighty Thousand Pesos Only (P 1,480,000.00)**;

**WHEREAS**, in response to the said advertisements, fifteen (15) prospective bidders were listed in the PhilGEPS document request list namely: Terabit Computer Systems Corporation, 3-Tech Innovation Master Corp., Integrated Computer Systems Inc., DCI Int'l I.T. Solutions and Services Corporation, U-Bix Corporation- Makati, Avid Sales Corporation, Agile Techfrontier Corp., Orogem's Tech. Marketing Corporation, Joneco tech Marketing Corp., Sun Impact Enterprise, Masangkay Computer Center, Proverbs Enterprises, Infoworx, Inc., HLYC Trading, and Pottspoint General Merchandise;

**WHEREAS**, a Pre-Bid Conference was conducted last 03 June 2022 at 2 o'clock in the afternoon and attended by four (4) prospective bidders: Joneco Tech Marketing Corp., 3-Tech Innovation Master Corp., Infoworx, Inc. and Jhiue and John Office Supplies and Equipment Trading;

**WHEREAS**, during the submission and opening of bids on June 15 and 16, 2022, respectively, no interested bidder purchased the bidding documents nor submitted bid proposal;

**WHEREAS**, as per Section 35.1 (a) of the IRR of RA 9184 there shall be a failure of bidding if no bids were received. Hence, this is the first failure of bidding;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **DECLARE** failure of bidding for the Supply and Delivery of ICT Equipment for PhilRice CES PB 22-02-14;
- b) To **RECOMMEND** for further review and evaluation of the technical specifications and/or budget by the Technical Working Group (TWG);
- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings
