



**BAC RESOLUTION RECOMMENDING AWARD FOR THE  
SUPPLY AND DELIVERY OF ONE (1) UNIT MOTOR VEHICLE (MULTI-PURPOSE  
VEHICLE) PB 22-03-16**

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of One (1) unit Motor Vehicle (Multi-Purpose Vehicle) PB 22-03-16** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **July 04 to 25, 2022**;

**WHEREAS**, the total approved budget for the contract (ABC) is **One Million Four Hundred Thousand Pesos Only (P1,400,000.00)**;

**WHEREAS**, in response to the said advertisements, five (5) prospective bidders were listed in the PhilGEPS document request list namely: Prince Motor Corporation, Elite North Autocars, Inc., SJ Legacy Motors, Inc., Genesis Auto Corp., and Honeyblest Trading;

**WHEREAS**, a Pre-Bid Conference was conducted last 12 July 2022 at 9 o'clock in the morning and attended by two (2) prospective bidders, Toyota Nueva Ecija, Inc. and FM Sales Corporation;

**WHEREAS**, Toyota Nueva Ecija Inc. purchased the bidding document and submitted proposal before the set deadline;

**WHEREAS**, during the submission and opening of bids held last **25 July** and **26 July, 2022** respectively, **Toyota Nueva Ecija, Inc.** was rated **PASSED** in the legal, technical and financial document and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of the **lone bidder** was found to be substantially complying and read as follows:

**WHEREAS**, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the lone bidder, Toyota Nueva Ecija, Inc., passed the legal, technical and financial document required;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **AWARD** the **Supply and Delivery of one (1) unit Motor Vehicle (Multi-Purpose Vehicle) PB 22-03-16** to **Toyota Nueva Ecija, Inc.** for being the **Single Calculated and Responsive Bid (SCRB)**;
- b) To **AWARD** to **Toyota Nueva Ecija Inc.** in the amount of One Million Three Hundred Ninety-Nine Thousand and Two Hundred Pesos Only (P 1,399,200.00);





- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings
