



BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF FUEL FOR FARM OPERATIONS AND GENERATOR SETS OF PHILRICE CES PB 22-03-20

BAC RESOLUTION No. 20 Series of 2022

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the Supply and Delivery of Fuel for Farm Operations and Generator Sets of PhilRice CES PB 22-03-20 in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from August 08 to 30, 2022;

WHEREAS, the total approved budget for the contract (ABC) is **Two Million Four Hundred Nine Thousand Pesos Only (P2,409,000.00)**;

WHEREAS, in response to the said advertisements, six (6) prospective bidders were listed in the PhilGEPS document request list namely: Superserve Corporation, Target Advertising and Marketing, Trade Venture International Corporation, Fil Generators and Services Company, Power Access Electrical Services, and Isometric Enterprises;

WHEREAS, a Pre-Bid Conference was conducted last 16 August 2022 at 9 o'clock in the morning and attended by two (2) prospective bidders, Phoenix Petroleum and Bantug Cooperative Gas Station;

WHEREAS, on 18 August 2022 Bid Bulletin No. 1 was issued to reflect changes in the Schedule of Requirements and Technical Specifications;

WHEREAS, during the submission and opening of bids on August 30 and 31, 2022, respectively, no interested bidder purchased the bidding documents nor submitted bid proposal;

WHEREAS, as per Section 35.1 (a) of the IRR of RA 9184 there shall be a failure of bidding if no bids were received. Hence, this is the first failure of bidding;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby **RESOLVED**:

- a) To **DECLARE** failure of bidding for the Supply and Delivery of Fuel for Farm Operations and Generator Sets of PhilRice CES PB 22-03-20;
- b) To **RECOMMEND** for further review and evaluation of the schedule of requirements, and/or budget by the end-users;
- c) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
