PROCLAMATION NO. 115

**DECLARING MONDAY, 26 DECEMBER 2022, AS A SPECIAL (NON-WORKING)  
DAY THROUGHOUT THE COUNTRY**

**WHEREAS**, 25 December 2022 (Christmas Day) which is observed as a regular holiday throughout the country falls on a Sunday;

**WHEREAS**, the declaration of 26 December 2022, Monday, as an additional special (non-working) day throughout the country will give the people the full opportunity to celebrate the holiday with their families and loved ones;

**WHEREAS**, a longer weekend will encourage families to get together and strengthen their relationship towards a more productive environment, and will promote domestic tourism.

**NOW, THEREFORE, I, FERDINAND R. MARCOS, JR.**, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Monday, 26 December 2022, as a special (non-working) day throughout the country.

The Department of Labor and Employment is hereby directed to issue the appropriate circular to implement this Proclamation for the private sector.

**IN WITNESS WHEREOF**, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 22<sup>nd</sup> day of December, in the year of Our Lord, Two Thousand and Twenty Two.
