



**BAC Resolution Recommending Award for the
Procurement of One (1) Lot Provision of Security Services PB 23-01-01EPA
BAC RESOLUTION No. 31
Series of 2022**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Procurement of One (1) Lot Provision of Security Services PB 23-01-01EPA** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **October 28 to November 22, 2022**;

WHEREAS, the total approved budget for the contract (ABC) is **Nine Million Seven Hundred Fifty-Three Thousand Four Hundred Thirty Eight and 69/100 Pesos Only (P9,753,438.69)**;

WHEREAS, in response to the said advertisements, ten (10) prospective bidders were listed in the PhilGEPS document request list: Yourguard Security and Investigation Agency Inc., Arviter Top of the Line Sec. Invest. Specialist, Baguio Investigation and Security Agency, Inc., RBP Compass Security and Investigation Agency, Northcom Security and Investigation Agency, Inc., Hero Security and Investigation Services, Light A and H Security Agency, Tough Guard Security and Investigation Agency Inc., Urduja Security Services, Inc., and ABC-RMO Security & Investigation Agency Inc.;

WHEREAS, a Pre-Bid Conference was conducted last 10 November 2022 at 9 o'clock in the morning and attended by three (3) prospective bidders, Light A and H Security Agency, Tough Guard Security and Investigation Agency Inc., and Urduja Security Services, Inc.;

WHEREAS, three (3) bidders, 1) Tough Guard Security and Investigation Agency Inc., 2) Urduja Security Services, Inc., and 3) Light A and H Security Agency purchased the bidding document and submitted proposal before the set deadline;

WHEREAS, during the submission and opening of bids held last **22 November** and **23 November, 2022** respectively, Tough Guard Security and Investigation Agency and Urduja Security Services, Inc. were rated **PASSED** in the technical and financial component and declared to be **ELIGIBLE**;

WHEREAS, Light A and H Security Agency declared **"FAILED"** due to incomplete document. Their computation of Net Financial Contracting Capacity (NFCC) was not included in the technical component (1st envelope);

WHEREAS, *Under Section 30 of the revised RA9184 and its IRR states that:*

*"The BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that **fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."***

WHEREAS, the financial proposal of the **two (2) bidders** who passed the technical and financial component were found to be substantially complying and read as follows:

Tough Guard Security and Investigation Agency Inc.,	9,735,791.52
Urduja Security Services, Inc.	9,609,811.69

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of the lowest calculated and responsive bidder, **Urduja Security Services Inc.** successfully met all the legal, technical and financial document required.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **AWARD** the **Procurement of One (1) Lot Provision of Security Services PB 23-01-01EPA** to **Urduja Security Services Inc.** for being the Lowest Calculated and Responsive Bid;
- b) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.
