



**BAC Resolution Recommending Award for the
Supply and Delivery of One (1) Unit Motor Vehicle for PhilRice CMU Satellite Station

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of One (1) Unit Motor Vehicle for PhilRice CMU Satellite Station PB 22-04-25** in the PhilRice Website, PhilGEPS and at conspicuous place in the premises of the Philippine Rice Research Institute continuously from **November 15 to December 05, 2022**;

WHEREAS, the total approved budget for the contract (ABC) is **One Million Six Hundred Thousand Pesos Only (P1,600,000.00)**;

WHEREAS, in response to the said advertisements, five (5) prospective bidders were listed in the PhilGEPS document request list: Persabe Merchandising, Learning Access Trading, Juantong Agri-Ventures, Inc., 3ME Buenamano Mktg. Inc., and VG Multi-Products Enterprises;

WHEREAS, a Pre-Bid Conference was conducted last 23 November 2022 at 3 o'clock in the afternoon and attended by four (4) prospective bidders, 1) Toyota Nueva Ecija Inc., 2) Isuzu Cabanatuan- BMD Motors, 3) Freeway Motor Sales of Cabanatuan Corp., 4) Marquay Trading;

WHEREAS, only one (1) bidder, Freeway Motor Sales of Cabanatuan Corp. purchased the bidding document and submitted proposal before the set deadline;

WHEREAS, on 28 November 2022, **Bid Bulletin No. 1** was issued to reflect the changes in the Section V. Special Conditions of Contract, Section VI. Schedule of Requirements and Section VII. Technical Specifications;

WHEREAS, during the submission and opening of bids held last **05 December** and **06 December, 2022** respectively, the lone bidder, **Freeway Motor Sales of Cabanatuan Corp.** was rated **PASSED** in the technical and financial component and declared to be **ELIGIBLE**;

WHEREAS, the financial proposal of the **lone bidder** who passed the technical and financial component were found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of the single calculated and responsive bidder, **Freeway Motor Sales of Cabanatuan Corp.** successfully met all the legal, technical and financial document required.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:



- b) To **RECOMMEND** for approval by the PhilRice Executive Director the foregoing findings.








