



**BAC Resolution Recommending Award for the  
Fabrication, Supply and Delivery of Customized Plastic Woven Sacks with Print  
PB 23-04-18**

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Fabrication, Supply and Delivery of Customized Plastic Woven Sacks with Print PB 23-04-18** on the PhilRice Website, PhilGEPS, and at a conspicuous place on the premises of the Philippine Rice Research Institute continuously from **19 October to 08 November 2023**;

**WHEREAS**, the total approved budget for the contract (ABC) is **Nineteen Million Eight Hundred Forty Five Thousand Pesos Only (P 19,845,000.00)**;

**WHEREAS**, in response to the said advertisements, four (4) prospective bidders were listed in the PhilGEPS document request list: 1) Cosmos Technomobile Inc., 2) Packware Phils. Inc., 3) Philippine Vision Group, Inc., and 4) Juantong AgriVentures, Inc.;

**WHEREAS**, a Pre-Bid Conference was conducted last 26 October 2023 at 9 o'clock in the morning and attended by three (3) prospective bidders: 1) Sencar Industrial Corporation, 2) Filzack Industries and Packaging Corporation, and 3) Golden Portal Industries, Inc.;

**WHEREAS**, **Bid Bulletin No. 1** was issued on 31 October 2023 to reflect the changes in Section VI, Schedule of Requirements and Section VII, Technical Specifications of the bidding documents for the changes made in the delivery period, delivery areas and technical specifications;

**WHEREAS**, there are three (3) bidders, 1) Filzack Industries Packaging Corp., 2) Sencar Industrial Corporation, and 3) Golden Portal Industries, Inc. purchased the bidding document and submitted the proposal before the set deadline;

**WHEREAS**, during the submission and opening of bids held last **8 and 9 November 2023**, all bidders were rated **PASSED** in the technical and financial component and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of the **above bidders** who passed the technical and financial component were found to be substantially complying and read as follows:


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:
