



**BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
SUPPLY AND DELIVERY OF RICE GRAIN SORTER AND RICE GRAIN GRADER  
FOR PHILRICE CES PB 23-03-15**

**BAC RESOLUTION No. 19  
Series of 2023**

**WHEREAS**, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Rice Grain Sorter and Rice Grain Grader for PhilRice CES** under **PB 23-03-15** on the PhilRice Website, PhilGEPS, and at a conspicuous place on the premises of the Philippine Rice Research Institute continuously from **20 July to 09 August 2023**;

**WHEREAS**, the total approved budget for the contract (ABC) is **One Million One Hundred Thousand Pesos Only (P 1,100,000.00)**;

**WHEREAS**, in response to the said advertisements, three (3) prospective bidders were listed in the PhilGEPS document request list: 1) ACT (Machineries and Metalcraft) Corporation, 2) Westpoint Engineering Supplies Incorporated, and 3) Shock and Awe Industrial Corporation;

**WHEREAS**, a pre-bid conference was conducted last 28 July 2023 at 9 o'clock in the morning and attended by two (2) prospective bidders: Shock and Awe Industrial Corporation and 3R Metal Craft;

**WHEREAS**, Shock and Awe Industrial Corporation purchased the bidding document and submitted the proposal before the set deadline;

**WHEREAS**, during the submission and opening of bids held last **09 August 2023**, Shock and Awe Industrial Corporation rated **PASSED** in the technical and financial component and declared to be **ELIGIBLE**;

**WHEREAS**, the financial proposal of the **above bidder** who passed the technical and financial components was found to be substantially complying and read as follows:

**WHEREAS**, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, Shock and Awe Industrial Corporation was hereby declared as **"post-disqualified"** due to non-compliance to the eligibility requirement with the following details:

**WHEREAS**, Notice of Post Disqualification was sent to Shock and Awe Industrial Corporation stating the abovementioned grounds for disqualification;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) To **DECLARE** failure of bidding due to the post-disqualification of the lone bidder Shock and Awe Industrial Corporation;
- b) To **REVIEW** and **CONDUCT** second bidding for the Supply and Delivery of Rice Grain Sorter and Rice Grain Grader reflecting any changes or updates in the bidding requirements as a result of the mandatory review of the terms, conditions and specifications if there are any; and
- c) To **RECOMMEND** the foregoing findings for approval by the PhilRice Executive Director.


