



BAC Resolution Recommending Award for the
PROCUREMENT OF FUELS THROUGH FLEET CARD SYSTEM
PB 24-01-03EPA

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for **Procurement of 2024 Fuels through Fleet Card System** under **PB 24-01-03EPA** on the PhilRice Website, PhilGEPS, and at a conspicuous place on the premises of the Philippine Rice Research Institute continuously from **14 November to 04 December 2023**;

WHEREAS, the total approved budget for the contract (ABC) is **FOURTEEN MILLION SEVEN HUNDRED NINETEEN THOUSAND THREE HUNDRED FIFTY-SIX PESOS AND 65/100 ONLY (Php 14,719,356.65)**;

WHEREAS, in response to the said advertisements, two (2) prospective bidders were listed in the PhilGEPS document request list :1) Northern Star Energy Corporation and 2) Shell Pilipinas and two (2) prospective bidders: 1) Northern Star Energy Corporation and 2) Petron Corporation attended the pre-bid conference last 21 November 2023;

WHEREAS, two (2) prospective bidders: 1) Northern Star Energy Corporation and 2) Petron Corporation purchased the bidding document and submitted the proposal before the set deadline;

WHEREAS, during the submission and opening of bids held last **04 and 05 December 2023**, the two (2) bidders were rated **PASSED** in the technical and financial component and declared to be **COMPLIANT**;

WHEREAS, the financial proposal of the **above bidders** who passed the technical and financial component were found to be substantially complying and read as follows:

WHEREAS, during the post-qualification evaluation, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted for the bidding, the bid of **Petron Corporation** successfully met all the legal, technical, and financial documents;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- To **AWARD** the **Procurement of 2024 Fuels through Fleet Card System** under **PB 24-01-03EPA** to **Petron Corporation** for offering the Lowest Calculated and Responsive Bid (LCRB);
- To **RECOMMEND** the foregoing findings for approval by the PhilRice Executive Director.
