



**BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
SUPPLY AND DELIVERY OF FUELS FOR GENERATOR SET AND AGRI MACHINERIES
OF PHILRICE CES PB 24-01-04EPA**

**BAC RESOLUTION No. 37
Series of 2023**

WHEREAS, the Philippine Rice Research Institute advertised the call for bidding for the **Supply and Delivery of Fuels for Generator set and Agri-Machineries of PhilRice CES** under **PB 24-01-04EPA** on the PhilRice Website, PhilGEPS, and at a conspicuous place on the premises of the Philippine Rice Research Institute continuously from **14 November to 04 December 2023**;

WHEREAS, the total approved budget for the contract (ABC) is **Four Million One Hundred Thirty Thousand Three Hundred Fifty Pesos and 30/100 Only (₱ 4,130,350.30)**;

WHEREAS, in response to the said advertisements, three (3) prospective bidders were listed in the PhilGEPS document request list: 1) Integrated Power and Control provider Incorporated, 2) Power Access Electrical Services, and 3) Tabuko Energy Network Corp.;

WHEREAS, a pre-bid conference was conducted last **21 November 2023** at 9 o'clock in the morning and attended by three (3) prospective bidders: 1) Primo Gas Station, 2) Roseville Gas Station, and 3) Bantug PMPC;

WHEREAS, during the submission and opening of bids on **04 and 05 December 2023**, respectively, no interested bidder purchased the bidding documents nor submitted bid proposal;

WHEREAS, as per Section 35.1 (a) of the IRR of RA 9184, there shall be a failure of bidding if no bids were received. Hence, this is the first failure of bidding;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:



- c) To **RECOMMEND** the foregoing findings for approval by the PhilRice Executive Director.


