

# BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF FUEL, OILS AND LUBRICANTS FOR THE YEAR 2024 OF PHILRICE CMU

#### RESOLUTION No. 18 Series of 2023

WHEREAS, the Philippine Rice Research Institute advertised the call for Public Bidding for the project Procurement of Fuel, Oils and Lubricants for the year 2024 of PhilRice CMU under PB AES 24-01-03 which is an Early Procurement Activity with an ABC amounting to One Million Nine Hundred Twenty-Three Thousand Pesos and 00/100 (P1,923,000.00);

**WHEREAS**, in response to the advertisement mentioned above, two prospective bidders were found in the Document Request List (DRL) of the PhilGEPS website, i.e., Absolute Advantage Trading and General Services Inc. and Goodfarms Trading Corporation;

WHEREAS, on November 29, 2023, the BAC convened for the scheduled Pre-bid Conference for the project;

WHEREAS, on December 12, 2023, Centro Supersales, Inc. of Agrosite, South Poblacion, Maramag, Bukidnon purchased the bidding document and subsequently submitted a bid proposal on December 14, 2023 at 8:54AM;

WHEREAS, on December 14, 2023, the BAC convened for the scheduled opening of bids for the project;

**WHEREAS**, during the bid opening, Centro Supersales, Inc., the lone bidder for the project, was rated **PASSED** and declared Eligible as per its eligibility and technical components (First Envelope);

**WHEREAS**, the Financial Proposal of Centro Supersales, Inc. was read as One Million Nine Hundred Twenty-Two Thousand Three Hundred Forty Pesos and 00/100 (P1,922,340.00);



WHEREAS, upon careful examination and evaluation of all the documents submitted for the bidding, it was found out that the eligibility and technical, as well as the financial documents required, were successfully met by the lone bidder, Centro Supersales, Inc.:






