

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF FUEL (DIESEL AND GASOLINE) OF RCEF PROGRAM FOR THE PERIOD APRIL – DECEMBER 2024

RESOLUTION No. 4 Series of 2024

WHEREAS, the Philippine Rice Research Institute advertised the call for Public Bidding for the project Procurement of Fuel (Diesel & Gasoline) of RCEF Program for the period April – December 2024 under PB AES 24-01-04 with an ABC amounting to One Million Five Hundred Fifty Thousand Seven Hundred Five Pesos and 00/100 (P1,550,705.00);

WHEREAS, in response to the advertisement mentioned above, one prospective bidder was found in the Document Request List (DRL) of the PhilGEPS website, i.e., Mindanao Island Oils of Butuan City;

WHEREAS, on March 8, 2024, the BAC convened for the scheduled Pre-bid Conference for the project which was attended by the authorized representative of Mindanao Island Oils;

WHEREAS, on March 14, 2024 D. Domingo Gasoline Station of Brgy. Mabini, Cabadbaran City purchased the bidding document and subsequently submitted a bid proposal on March 15, 2023 at 1:50PM;

WHEREAS, Mindanao Island Oils of P-6, Villa Kananga, Butuan City also purchased bidding document on March 19, 2024 and thereafter submitted a bid proposal on March 20, 2023 at 8:25AM;

WHEREAS, on March 20, 2024 at exactly 10:00AM, the BAC convened for the scheduled opening of bids for the project;

WHEREAS, during the bid opening, the Eligibility and Technical components (First Envelope) of D. Domingo Gasoline Station was evaluated first and noticed that the Statement of Single Largest Completed Contract (SLCC) did not reflect the name and signature of the proprietor/authorized representative of its company;

WHEREAS, the Statement of Single Largest Completed Contract of D. Domingo Gasoline Station failed to reflect important details such as contract effectivity and completion date and no Certificate of Acceptance and Certificate of Completion attached to support its statement;

WHEREAS, the receipt of Bid Proposal was on March 15, 2024, however the attached Bid Securing Declaration and Omnibus Sword Statement was notarized and dated March 20, 2024 making uncertainty on the truthfulness of the said documents;

WHEREAS, after thorough deliberation and given the grounds presented above, the Bids and Awards Committee and TWG – Goods & Services unanimously decided to disqualify of D. Domingo Gasoline Station;

WHEREAS, the Bids and Awards Committee then proceeded to the second prospective bidder, Mindanao Island Oils;

WHEREAS, Mindanao Island Oils was rated PASSED and declared Eligible as per its Eligibility and Technical components (First Envelope);

WHEREAS, the Financial Proposal of Mindanao Island Oils was opened and read as One Million Three Hundred Eighty-Seven Thousand Seven Hundred Six Pesos and 00/100 (P1,387,706.00);

WHEREAS, upon careful examination and evaluation of all the documents submitted for the bidding, it was found out that the eligibility and technical, as well as the financial documents required, were successfully met by the remaining eligible bidder, Mindanao Island Oils;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE as it is hereby RESOLVED:

- To AWARD the Procurement of Fuel (Diesel & Gasoline) of RCEF Program for the period April – December 2024 under PB AES 24-01-04 to Mindanao Island Oils of P-6, Villa Kananga, Butuan City, in the amount of One Million Three Hundred Eighty- Seven Thousand Seven Hundred Six Pesos and 00/100 (P1,387,706.00), for having the Single Calculated and Responsive Bid (SCRB); and
- To RECOMMEND for approval by the Branch Director, the foregoing findings.





CONTRACT AGREEMENT

THIS AGREEMENT made the <u>27th</u> day of March 2024 between PHILIPPINE RICE RESEARCH INSTITUTE – AGUSAN EXPERIMENT STATION of the Philippines (hereinafter called "the Entity") of the one part and MINDANAO ISLAND OILS of P-6, Villa Kananga, Butuan City, Philippines (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


