



**BAC RESOLUTION RECOMMENDING AWARD FOR THE
SUPPLY AND DELIVERY OF ONE (1) UNIT GEL ELECTROPHORESIS SYSTEM & ONE (1)
UNIT THERMAL CYCLER PB 25-01-09**

**BAC RESOLUTION No. 08
Series of 2025**

WHEREAS, the DA-Philippine Rice Research Institute advertised the call for bidding for the Supply and Delivery of One (1) Unit Gel Electrophoresis System & One (1) Unit Thermal Cyclor PB 25-01-09 on PhilGEPS 1.5, Modernized PhilGEPS, PhilRice websites and at conspicuous places continuously from **13 Feb to 07 March 2025**;

WHEREAS, the total approved budget for the contract (ABC) is Seven Hundred Twenty Thousand Pesos Only (₱720,000.00);

WHEREAS, in response to the said advertisements, twenty-two (22) prospective bidders were listed in the PhilGEPS 1.5 document request list namely: 1) Golden Bat (Far East), Inc., 2) Guill-Bern Corporation, 3) Mt. Zion Scientific, Inc., 4) Diamed Enterprise, 5) Medical Test Systems Inc., 6) Omnibus Bio-Medical Systems, Inc., 7) Chemline Scientific Corporation, 8) Eliasaph Diagnostics Solutions Inc., 9) ITS Science (Phils), Inc, 10) Fil-Anaserve, Inc., 11) Mettler - Toledo Philippines, Inc., 12) Pro Maintech Consultancy Inc., 13) Noveaulab Asia Corp., 14) Presidium.Ph Corporation, 15) Krypton International Resources Sales & Services Inc., 16) MMJ Biosystems Philippines, Inc., 17) Healthqo Laboratory Supplies Trading, 18) Bytes Tech Solutions Corp, 19) Rainphil, Inc., 20) Carefield Analytical Solutions Inc., 21) Double Helix Scientific Corporation, and 22) Lifeline Diagnostics Supplies, Inc.;

WHEREAS, a Pre-Bid Conference was conducted on 21 February 2024 at 2:00 PM. via Zoom and attended virtually by six (6) prospective bidders namely, 1) Noveaulab Asia Corp., 2) Lifeline Diagnostic Supplies, Inc., 3) Microgenetix, Inc., 4) Rainphil Inc., 5) Medical Test Systems, Inc., and 6) QR Scientific;

WHEREAS, on 28 February 2025, **Bid Bulletin No. 1** was issued to reflect the changes in Section VI Schedule of Requirements and Section VII Technical Specifications in the bidding document;

WHEREAS, six (6) bidders purchased the bidding document and submitted the proposal before the set deadline namely, 1) Rainphil, Inc., 2) Medical Test System Inc., 3) Lifeline Diagnostic Supplies Inc., 4) Microgenetix Inc., 5) Fil-Anaserve Inc., and 6) Noveaulab Asia Corp.;

WHEREAS, during the opening of bids held last **07 March 2025 at 2:00 P.M.**, a preliminary examination of bids was conducted. The Bids and Awards Committee (BAC), with the assistance of the BAC Secretariat, opens the first bid envelope to determine each bidder's compliance with the document required to be submitted for eligibility and the technical requirements, as prescribed in the IRR. The BAC checked each bidder's submitted documents as per the checklist of required documents to ascertain if they were all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders;

WHEREAS, the BAC, after thoroughly examining the submitted eligibility and technical documents, all the bidders were declared **"PASSED."**

WHEREAS, the financial proposals of the bidders were found to be substantially complying and read as follows:

WHEREAS, on 17 March 2025, after the post-qualification evaluation and notwithstanding any pending request for reconsideration, the BAC initiated and completed the same post-qualification process on the bidders with the next Lowest Calculated Bidder and found that the bids submitted by Fil-Anaserve, Inc. and, Microgenetix Inc. for both Lot 1 and 2, as well as those submitted by Noveaulab Asia Corp., Rainphil, Inc., and Medical Test Systems, Inc. for Lot 2, did not comply with the required technical specifications stated in the Bidding Document. Consequently, these bidders have been declared **NON-RESPONSIVE** and are hereby **POST-DISQUALIFIED**;

WHEREAS, upon careful examination, verification, validation, and ascertainment of all statements and representations made including all documents submitted for the bidding, it was found that the bids from RainPhil Inc. and Lifeline Diagnostics Supplies Inc. for **Lot 1 & Lot 2**, respectively, **PASSED** all the criteria for post-qualification thus, they were declared **RESPONSIVE** for the said lots;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To **AWARD** to Rainphil Inc., and Lifeline Diagnostics Supplies Inc.’s the Lot 1- One (1) unit Gel Electrophoresis System and Lot 2 One (1) unit Thermal Cycler, respectively, for being the Lowest Calculated and Responsive Bid (LCRB);
- b) **To RECOMMEND** the foregoing findings for approval by the PhilRice Executive Director.
