## PROCUREMENT OF VARIOUS AGRICULTURAL SUPPLIES FOR WS 2024 IN PHILRICE CMU

**WHEREAS**, the Philippine Rice Research Institute advertised the call for Public Bidding for the project **Procurement of various Agricultural Supplies for WS 2024 in PhilRice CMU under PB AES 24-02-05** with an ABC amounting to **Two Million Four Hundred Four Thousand Six Hundred Twenty – Three And 00/100 Pesos (P2,404,623.00)**;

**WHEREAS**, in response to the advertisement mentioned above, eight (8) prospective bidders were found in the Document Request List (DRL) of the PhilGEPS website, viz., Enviro Scope Synergy Inc, PRC Marketing, GoodFarms Trading Corporation, Jeels Masagana Farm Supply, Inc., Pacquaio Fruit Trees Nursery, Christian Aromanon Manobo Muslim Free Farmers Multipurpose Cooperative, VG Multi-Products Enterprises, and Jemarge Agri Products Corporation;

**WHEREAS**, on May 14, 2024, Northern Agro, Inc of Kidapawan City, North Cotabato purchased the bidding document and on May 22, 2024, PRC Marketing purchased bidding document;

**WHEREAS**, on May 15, 2024, the BAC convened for the scheduled Pre-bid Conference for the project;

**WHEREAS**, on May 27, 2024, Northern Agro, Inc submitted a bid proposal at 01:15PM;

**WHEREAS**, on May 28, 2024, the BAC convened for the scheduled opening of bids for the project;

**WHEREAS**, during the bid opening, Northern Agro, Inc., the lone bidder for the project, was rated **PASSED** and declared Eligible as per its eligibility and technical components (First Envelope);

**WHEREAS**, the Financial Proposal of Northern Agro, Inc. was read as **Two Million Three Hundred Eighty - Four Thousand Two Hundred Twenty - Nine Pesos and 00/100 (P2,384,229.00)**;

**WHEREAS**, on June 3, 2024, the TWG – Agricultural Inputs and the Provisional member conducted post qualification evaluation;

## CONTRACT AGREEMENT

THIS AGREEMENT made on 18<sup>TH</sup> day of JUNE, 2024  
between **PHILIPPINE RICE RESEARCH INSTITUTE – FIELD OFFICE CMU** of the Philippines (hereinafter called “the Entity”) of the one part and **NORTHERN AGRO, INC.** of Jose Abad Santos St., Kidapawan City, North Cotabato (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Supply and Delivery of various Agricultural Inputs for WS 2024 in PhilRice CMU under PB AES 24-02-05** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Three Hundred Eighty-Four Thousand Two Hundred Twenty-Nine Pesos Only (Php 2,384,229.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


