WHEREAS, the Philippine Rice Research Institute advertised the call for Public Bidding for the project **Supply, Delivery, and Installation of 1 Unit Generator Set for PhilRice Agusan under PB AES 25-02-04** with an ABC amounting to **One Million Four Hundred Thousand Pesos and 00/100 (P1,400,000.00)**;

WHEREAS, in response to the advertisement described above, there was one (1) bidder downloaded the Bid Notice in Modernized PhilGEPS, i.e., R.E. Pabuaya Construction;

WHEREAS, on May 7, 2025 9:00AM, the BAC convened for the scheduled Pre-bid Conference for the project;

WHEREAS, on May 8, 2025, Ultraquip Enterprises Inc. purchased the bidding document and subsequently submitted a bid proposal at the prescribed time;

WHEREAS, on May 26, 2025 at 10:00AM, the BAC convened for the scheduled opening of bids for the project;

WHEREAS, during the Bid Opening, Ultraquip Enterprises Inc., the lone bidder for the project, was rated **PASSED** and declared Eligible as per its eligibility and technical components (First Envelope);

WHEREAS, the Financial Proposal of Ultraquip Enterprises Inc. was read as One Million Three Hundred Eighty Thousand Pesos and 00/100 (P1,380,000.00);

WHEREAS, upon careful examination and evaluation of all the documents submitted for the bidding, it was found out that the eligibility and technical, as well as the financial documents required, were successfully met by the lone bidder, Ultraquip Enterprises Inc.;

WHEREAS, during the Detailed Bid Evaluation, the Bids and Awards Committee and TWG agreed to schedule post-qualification evaluation on May 28 – 30 ,2025;

WHEREAS, on May 28, 2025, the Technical Working Group conduct its post-qualification to the Municipality of Las Nieves, the declared Single Largest and Completed Contract (SLCC) of Ultraquip Enterprises Inc. in Las Nieves, Agusan del Norte;

CONTRACT AGREEMENT



THIS AGREEMENT made the 17th day of June 2025 between **PHILIPPINE RICE RESEARCH INSTITUTE AGUSAN** of the Philippines (hereinafter called "the Entity") of the one part and **ULTRAQUIP ENTERPRISES INC.** of Purok 4-C, Km. 7.5, Diversion Road, Matina Pangi, Davao City, Davao del Sur, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Supply and Delivery of Walk-behind Transplanter for PhilRice Agusan under PB AES 25-02-05** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Hundred Fifty - Five Thousand Pesos and 00/100; Php 555,000.00** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Five Hundred Fifty - Five Thousand Pesos and 00/100; Php 555,000.00 or such other sums as may be ascertained, **Ultraquip Enterprises Inc.** agrees the **Supply and Delivery of Walk-behind Transplanter for PhilRice Agusan under PB AES 25-02-05** in accordance with his/her/its Bid.
4. The Philippine Rice Research Institute Agusan agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. Ultraquip Enterprises Inc. shall provide a warranty for a period of two (2) years after the delivery of the machine and a provision of after sales service and assistance, and in addition, spare parts should be locally available.
6. Ultraquip Enterprises Inc. agrees to render services through the winning bidders' accredited service center in CARAGA Region under the company name of JV Car Care Services located in Brgy. Kinamlutan, Butuan City, Agusan del Norte.
7. Any dispute arising out of this contract shall exclusively be brought before the 1st Municipal Circuit Trial Court (Magallanes-Las Nieves-Remedios T. Romualdez) or the Regional Trial Court of Cabadbaran City, Agusan del Norte.
